ORDER

The State Government has constituted a Commissionerate of Police at Chandannagar in Hooghly District vide Home & Hill Affairs Department, Police Establishment Branch Notification Nos. 2467-PL dated 15/06/2017, 2468-PL dated 15/06/2017 and 2469-PL dated 15/06/2017 respectively consisting of the areas and boundaries as described therein. The Commissioner of Police of the newly constituted Police Commissionerate of Chandannagar will issue "NO OBJECTION CERTIFICATE" without which the Excise Licence under the Bengal Excise Act 1909 shall not be granted or re-newed by the Excise Collector of the concerned Hooghly District.

It is, therefore, directed that the Collector of Excise, Hooghly shall not henceforth grant Excise Licenses to persons, unless the following conditions are met :-

- 1) A certificate is issued by the concerned Commissioner of Police, stating that a licence may be granted to the applicant for the sale of spirituous liquors or intoxicating drugs, as the case may be, without risk or detriment to the preservation of peace or good order, and containing full statement of such conditions as may be imposed and shall remain in force, on the date when such licence shall be granted.
- 2) The licence so granted shall not be renewable without a fresh certificate as aforesaid, previously obtained from the concerned Commissioner of Police.

- 3) The certificate thus issued shall remain vliid for a period ending on 31st March of every year or till the end of the ongoing Excise Licensing year and subject to such conditions as may be deemed necessary for securing the good behaviour of the keepers of the houses and the places of entertainment and for the prevention of drunkenness and disorder among the persons frequenting or using the same, which may be verified from time to time.

No. 2936-ICA(N)/IC/O/3A(VII)-04/2017, Dated, Howrah the 16th October, 2017, WHEREAS the State Government have vide No. 2468-PL dated 15/06/2017, declared the areas and boundaries of Chandannagar Police Commissionerate, as fully described in the schedule appended with the Notification No. 2467-PL dated 15/06/2017, as metropolitan area, on and from 30/06/2017.

AND WHEREAS the State Government have conferred on Commissioner of Police, Chandannagar, all powers of an Executive Magistrate in relation to the said metropolitan area of Chandannagar Police Commissionerate, vide Notification No. 2470-PL dated 15/06/2017.

AND WHEREAS, it is felt expedient and necessary to specify an authority which shall be the licencing authority for the purposes of the West Bengal Cinemas (Regulation) Act 1954, in respect of the said metropolitan area.

NOW, THEREFORE, in exercise of the power conferred by provision to Section 4 of the West Bengal Cinemas (Regulation) Act 1954, the Governor is placed hereby to specify the Commissioner of Police, Chandannagar, as the licencing authority for the purpose of the Act in respect of the said metropolitan area of the Chandannagar Police Commissionerate with effect from 30/06/2017.
