In exercise of the power conferred by the proviso to article 309 of the Constitution of India, the Governor is hereby pleased to make the following rules regulating inter se seniority of the members of West Bengal Police Service :-

**Rules**

1. **Short title, commencement and application** –(a) These rules may be called the West Bengal Police Service (Determination of Seniority) Rules, 2018.
  - (b) They shall come into force on the date of their publication in the Official Gazette.
  - © They shall apply to the members of the West Bengal Police Service appointed to the service either by direct recruitment or by promotion.
2. **Definition :-** In these rules, unless the context otherwise requires, -
  - (a) "Commission" means the Public Service Commission, West Bengal;
  - (b) "Direct recruit" means a number appointed directly through competitive examination held by the Commission in accordance with the recruitment rules;
  - © "Promotee" means a member appointed by promotion from any of the feeder posts or services in accordance with recruitment rules;
  - (d) "Service" means the West Bengal Police Service;
  - (e) "Member" means the member of the Service;
  - (f) "Year of allotment" means in case of both direct recruits and promotion, the year in which recommendations are made by the Commission of the State Government.
3. **Seniority of members of West Bengal Police Service officers :-**
  - (1) Inter se seniority of the direct recruits appointed on the basis of examination held by Commission shall be determined on the basis of the aggregate of :-

- (i) Total marks obtained in West Bengal Civil Service (Executive) etc. Examination conducted by the Commission; and
- (ii) Total marks obtained out of 200 marks in the Induction Training comprising
  - (a) Basic Training at Swami Vivekananda State Police Academy, Barrackpore
    - A. Indoor Subjects – 80 marks,
    - B. Outdoor Subjects – 60 marks
  - (b) District Practical Training and Attachments – 40 marks,
  - (c) Assessment of Director, Swami Vivekananda State Police Academy – 20:

Provided that in case of a tie in the aggregate of marks obtained in West Bengal Civil Service (Executive) etc. Examination and Induction Training, the officer who has secured higher marks at West Bengal Civil Service (Executive) etc. Examination by the Commission shall be given preference in the order of seniority.

- (2) Officers appointed on the basis of result of an earlier year of such examination conducted by the Commission shall be senior to the officers appointed on the basis of result of a subsequent year of the said examination.
- (3) The seniority of promotes shall be determined according to their year of allotment and the relative seniority of promotes shall be determined by the order in which they are selected for appointment to the service on the recommendation of the Commission, members appointed on the result of an earlier selection being senior to the members appointed on the result of a subsequent selection.
- (4) The relative seniority between a promotee and a direct recruit shall be determined according to the respective year of allotment, promotees of a year of allotment being en-block senior to the direct recruits of the same year irrespective of the date of joining.
- (4) **Interpretation** – If any question arises relating to the interpretation of these rules, it shall be referred to the Government in the Home and Hill Affairs Department whose decision thereon shall be final
- (5) **Rules to have overriding effect** – The provisions of these rules shall have effect notwithstanding anything to the contrary contained in any other rules, orders or memoranda :

Provided that the case of promotion or appointment of members to higher service/grade or post already effected prior to the commencement of these rules shall not be affected.
