MINUTES OF THE MEETING OF THE BOARD OF CONTROL FOR EXAMINATION & PROMOTION HELD ON 19TH DECEMBER, 2018.

A meeting of the Board of Control for Examination and Promotion was held on 19th December, 2018 at 12.00 hrs. in the office chamber of the Addl. Director General of Police (Operation), West Bengal at Bhabani Bhawan, Kolkata- 27.

Shri Natarajan Ramesh Babu, IPS, Additional Director General & Inspector General of Police (Operation), West Bengal and Chairman of the Board presided over the meeting.

The following members of the Board attended the meeting-

1. Length-cum-Record of Service Board of C/1737 Sankar Sen of Nadia Dist. For promotion to the rank of ASI(UB) of PPT Batch No.04/2014.

- DIG, Training-Cum-Principal, SVSPA, WB informed vide his Memo no-SVSPA/PPT/MISC-ENQ-15(1)2018-22 dtd-12/10/18, that C/1737 Sankar Sen of Nadia District had undergone PPT Course for promotion to the rank of ASI(UB) in the year 2014. In Final Examination he was disqualified in 2 indoor subjects i.e. (1) Police Organisation & Social Awareness and (2) Basic Course in Computer. He obtained '0' marks in each subject out of full marks of '10'. Later, he appeared in the supplementary examination of both the subjects held in the year 2015 and was qualified in both the subjects which was duly reflected in the result sheet. But due to typographical mistake he was shown disqualified in the result sheet in another 2 subjects i.e. (1) Law and Procedure and (2) Maintenance of Registers at PS & Others, in which he had already passed in the year 2014. On scrutiny it appears that he had qualified in all the subjects and he is fit for getting promotion to the rank of ASI(UB).
- After receiving the above Memo from DIG, Training-Cum-Principal, SVSPA, WB, DIG, Murshidabad Range was requested to hold L-C-R-S Board in respect of C/1737 Sankar Sen of Nadia vide this office memo no-1349-Per/A//Per/A-25/17 (Pt) dtd-16/11/2018.
- DIG, Murshidabad Range held the Range Board on 28/11/2018 and sent his report vide his memo no-1252/CI/RHQ dtd-30/11/2018.

- It is to mention here that C/1737 Sankar Sen will retire from service on superannuation on 31/12/2018.
- The L-C-R-S Broad Sheet in respect of C/1737 Sankar Sen of Nadia has been placed before the Board for decision.

DECISION- The Board members perused the Broad sheet containing marks obtained by the candidate in the Pre-Promotional Training Course, Length-cum-Record of Service and other relevant records, the members of the Board are of the opinion that C/1737 Sankar Sen of Nadia district is declared 'Fit' for promotion to the rank of ASI(UB).

2. Length-cum-Record of Service Board of 12 Wireless Operators (ASI rank) for promotion to the rank of Supervisor (Operational/ Technical) Grade-II (SI rank) after completion of PPT Course -

- ADG & IGP, Telecommunication, West Bengal sent vide his memo no-399/RO dtd-28/09/2018, the L-C-R-S Broad Sheet of eligible 11 Wireless Operators (ASI Rank) of batch no 2003 who have completed PPT course successfully for promotion to the rank of Supervisor (Operational) Grade-II (SI rank).
- He has also sent the Broad Sheet approved by L-C-R-S Board in respect of W/ Opr. samir Saha of Telecom, HQ for promotion to the rank of Supervisor (Technical) Grade-II (SI rank). It is to mention here that the matter was placed before BOC meeting held on 04/07/2018, where the Board decided to adopt 'Sealed Cover' procedure due to pendency of departmental proceeding vide proceeding no-01/2018 dtd- 18/05/2018 of Telecom, WB. Final order was passed by SP, Telecom, WB that the charged wireless operator Samir Saha is excused this time with 'censure' vide DO No-604 dtd- 03/07/2018. At present W/Opr. Samir Saha has been exonerated from the charge and is now eligible for promotion to the rank of Supervisor (Technical) Grade-II.
- Two Broad Sheets in respect of the aforesaid 12 Wireless Operators (11+1) has been placed before the Board for decision.

DECISION- The Broad Sheet containing marks obtained by the wireless operators in the Pre-Promotional Training Course, Length-cum-Record of Service and other relevant records were placed before the members of the Board for consideration.

The members of the Board are of the opinion that all the 11-Wireless Operators (ASI rank) are declared 'Fit' for promotion to the rank of Supervisors (Operational) Grade-II (SI rank) [List enclosed].

The members of the Board have also opined that W/Opr. Samir Saha of Telecom, HQ is declared 'fit' for promotion to the rank of Supervisor (Technical) Grade-II (SI rank).

3. Disposal of court case in respect of six Constables of SSF Bn., BKP who have qualified in Deptt. Promotion to the rank of ASI (UB/AB)-

- DIG, Armed Police, Barrackpore has sent a letter vide his memo no- 449/RO dtd- 04/07/2018 regarding disposal of court case in respect of six Constables of SSF Bn., BKP who have qualified in departmental promotion to the rank of ASI (UB/AB).
- It is to mention here that C/213 Bhim Bouri, C/413 Subhadip Ghosh and C/546 Joydeb Paul of SSF Bn have passed in the departmental examination for promotion to the rank of ASI (Unarmed Branch) and C/255 Suman Bhowmik, C/456 Sumon Kumar Ghosh and C/462 Bappaditya Bhattacharjee of SSF Bn have passed in the departmental examination for promotion to the rank of ASI (Armed Branch).
- Their matters were placed before the Board of Control for examination and Promotion held on 26/04/2017 with others for consideration for their promotion. The members of the Board examined their matters and resolved that, though they were fit as per record but due to pendency of the criminal case [Titagarh PS Case No. 1/16 dtd-01/01/2016 u/s 147/ 148/ 149/ 341/ 332/ 186/326/ 427/ 353 IPC [ref. P 5488 dtd-15/05/2018 GR Case no- 80/16], 'Sealed Cover' procedure was followed against them.
- DIG AP, BKP forwarded the letter of CO, SSF Bn vide Memo no-1082 dtd- 21/06/2018 along with a copy of the judgement passed by the Ld. 2nd JM 1st Class Barrackpore on 08/05/2018 which revealed that the 6 Constables were found not guilty in Titagarh PS Case No.1/16 dtd-01/01/2016 [ref. P 5488 dtd- 15/05/2018 GR case no- 80/16].
- The matter was placed before BOC for Exam and Promotion for decision.

DECISION- As closed cover procedure was adopted in the BOC held on 26/04/2017, the closed envelop has been opened. The members of the Board examined their matter and resolved that the 6 Constables would be declared 'fit' w.e.f. 26/04/2017. C/213 Bhim Bouri, C/413 Subhadip Ghosh and C/546 Joydeb Paul of SSF Bn are declared 'fit' for promotion to the rank of ASI (Unarmed Branch) and C/255 Suman Bhowmik, C/456 Sumon Kumar Ghosh and C/462 Bappaditya Bhattacharjee of SSF Bn are declared 'fit' for promotion to the rank of ASI(Armed Branch). They will get their promotional benefit in accordance with their immediate junior.

- (i) **Promotion matter of C/112 Paresh Rasaily of Kalimpong (formerly C/1348 of Darjeeling district).**
 - C/112 Paresh Rasaily of Kalimpong (formerly C/1348 of Darjeeling district) has passed the departmental examination in 2003 and he was declared 'fit' for promotion to the rank of ASI(UB) in the meeting of BOC for Examination and Promotion and subsequently, he has posted to Darjeeling district vide this Office Memo No 640(80) Per/A//Per/A-03/2011 dtd-06/05/2015 (Sl. - But at that time he did not get promotion to the rank of ASI(UB) due to currency of Punishment (Proc. No- 01/2015 dtd-07/03/2015). The final order was passed awarding him a stoppage of one increment for a period of one year w.e.f. 01/05/2015 to 30/04/2016 without any future effect vide DO No-1412 dtd-22/04/2015. The punishment period has been completed and his pay has been regularized w.e.f. 01/05/2016 vide DO No-808 dtd-28/03/2016.
- Another departmental proceeding no-12/2016 dtd-08/11/2016 was drawn up against him. The final order was passed awarding him a stoppage of one increment for a period of one year without any future effect vide DO No-3149 dtd-31/12/2016. The punishment period has been completed and his pay was regularised w.e.f. 01/01/2018 vide DO No-60 dtd- 10/01/2018.
- The matter is placed before the board of Control for Examination and Promotion, whether he may be allowed to join his new assignment on promotion as ASI(UB) as was ordered earlier.

DECISION- The Board members opined that, C/112 Paresh Rasaily of Kalimpong (formerly C/1348 of Darjeeling district) may be allowed to join his new assignment as ASI(UB) as was ordered vide this office memo no-640 (80) Per/A//Per/A-03/2011 dtd-06/05/2015 (Sl. No-127).

(ii) **Promotion matter of C/16613, Dipankar Gangopadhyay of T.P, Kolkata Police to the rank of ASI-**

- C/16613, Dipankar Gangopadhyay of T.P, Kolkata Police is now working in Purba Bardhaman District under WBP on deputation vide Govt. of West Bengal, Home Department, Police Establishment Branch Order No.1952/PL/PB/14M-49/14 dt.20/06/2016.
- Jt. Commissioner of Police, Headquarters, Kolkata informed this office vide his Memo No.2587/3/CRO dt.28/11/2018 that the said Constable has been promoted to the rank of ASI vide Order No.1012 Dt.27/11/2018 of Dy. Commissioner of Police, 1st Bn. KAP (copy enclosed). The matter of the said promotion order was placed before the Board of Control for Examination and Promotion for approval.

DECISION- The Board members approved the promotion in respect of C/16613 Dipankar Gangopadhyay of T.P, Kolkata Police now working in Purba Bardhaman District on deputation to the rank of ASI with effect from the date of receipt of his promotion order at West Bengal Police Directorate i.e. 30/11/2018.

- The matter was placed before BOC for decision.

DECISION- After discussion the Board members have accepted the unwillingness prayer in respect of C/704 Tuhin Biswas of SAP 6th Bn for promotion to the rank of ASI(AB). CO, SAP 6th Bn, BKP is requested to strictly follow the GO No-9120-F dtd-13/11/2000 of Finance Department, Audit Branch, Govt. of WB in this regard. The Constable will not be entitled to any benefit under CAS 1990 and it should be recorded in his service book with an intimation to DIG (Administration), West Bengal.

(iv) **Unwillingness prayer C/121 Sanjit Sarkar of Dakshin Dinajpur (formerly C/783 of Malda) for promotion to the rank of ASI (AB)-**

- C/121 Sanjit Sarkar of Dakshin Dinajpur (formerly C/783 of Malda) was declared fit for promotion to the rank of ASI(AB) in the meeting of BOC for Examination and Promotion held on 26/04/2017.
- The said constable submitted a prayer expressing his unwillingness to take promotion to the rank of ASI(AB) due to family problem which was forwarded by SP, Dakshin Dinajpur vide memo no-1132/RO dtd-08/11/2018.
- SP, Dakshin Dinajpur also sent the concerned DO copy vide DO No-2116 dtd- 17/12/2018.
- The matter was placed before BOC for decision.

DECISION- After discussion the Board members have accepted the unwillingness prayer in respect of C/121 Sanjit Sarkar of Dakshin Dinajpur (formerly C/783 of Malda). SP, Dakshin Dinajpur is requested to strictly follow the GO No-9120-F dtd-13/11/2000 of Finance Department, Audit Branch, Govt. of WB in this regard. The Constable will not be entitled to any benefit under CAS 1990 and it should be recorded in his service book with an intimation to DIG (Administration), West Bengal.

(v) **Consideration of prayer regarding forgoing of promotion in respect of C/244 Sadhan Hazra SSF Bn, BKP to the rank of ASI(AB) –**

- C/244 Sadhan Hazra of SSF Bn, BKP was declared fit for promotion to the rank of ASI(AB) in the meeting of BOC for Examination and Promotion and subsequently he was posted on promotion to SSF Bn to the rank of ASI(AB) vide this office memo no-1119(168)-Per/A//Per/A-25/2016 dtd-14/09/2018 [Sl. No-B. 433].
- The constable submitted a prayer expressing unwillingness to take promotion to the rank of ASI(AB) due to personal problem which was forwarded by DIG, AP, Barrackpore under his memo no-675/F55-2018 dtd-11/09/2018 along with a copy of Memo No-1636 dtd-05/09/2018 of CO, SSF Bn and copy of BO No-1407 dtd-04/09/2018 regarding forgoing the promotion in favour of the incumbent.
- The matter was placed before BOC for decision.

DECISION- After discussion the Board members have accepted the prayer of C/244 Sadhan Hazra of SSF Bn, BKP to forgo the promotion to the rank of ASI(AB). CO, SSF Bn, BKP is requested to strictly follow the GO No-9120-F dtd-13/11/2000 of Finance Department, Audit Branch, Govt. of WB in this regard. The Constable will not be entitled to any benefit under CAS 1990 and it should be recorded in his service book with an intimation to DIG (Administration), West Bengal.

The Board also decided that the promotion order in respect of C/244 Sadhan Hazra of SSF Bn, BKP to SSF Bn, BKP as ASI(AB) will be placed before PEB for cancellation.

(vi) **Consideration of prayer regarding forgoing of promotion in respect of C/1922 Abdul Alif of SAP 1st Bn, BKP to the rank of ASI(AB) –**

- C/1922 Abdul Alif of SAP 1st Bn, BKP was declared fit for promotion to the rank of ASI(AB) in the meeting of BOC for Examination and Promotion and subsequently he was posted on promotion to SAP 1st Bn, BKP to the rank of ASI(AB) vide this office memo no-1119(168)-Per/A//PER/A-25/2016 dtd-14/09/2018 [Sl. - The constable submitted prayer expressing his unwillingness to take promotion to the rank of ASI(AB) due to personal problem which was forwarded by DIG, AP, Barrackpore under his memo no-789/F55-2018 dtd-26/10/2018 along with a copy of Memo No-3099 dtd-09/10/2018 of CO, SAP 1st Bn and copy of BO No-1712 dtd-14/12/2018 regarding forgoing of promotion in favour of the incumbent.
- The matter was placed before BOC for decision.

- **DECISION-** After discussion the Board members have accepted the prayer of C/1922 Abdul Alif of SAP 1st Bn, BKP to forgo the promotion to the rank

- The Board also decided that the promotion order in respect of C/244, C/1922 Abdul Alif of SAP 1st Bn, BKP to SAP 1st Bn, BKP as ASI(AB) will be placed before PEB for cancellation.

(vii) **Consideration of prayer regarding forgoing of promotion in respect of C/508 Ashok Kumar Upadhyay of 1st IR Bn, Durgapur to the rank of ASI(AB) –**

- The constable subsequently submitted prayer expressing his unwillingness to take promotion to the rank of ASI(AB) as he has successfully completed PPT Course and qualified to the rank of ASI(UB) in future which was forwarded by CO, 1st IR Bn, DGP under his memo no-536/RO dtd-01/10/2018 along with a copy of Memo No-534/RO dtd-26/09/2018.
- CO, 1st IR Bn, DGP also forwarded the unwillingness BO copy (BO No-1191 dtd-14/12/2018) vide his memo no 591/RO dtd-14/12/2018 regarding unwillingness to take promotion to the rank of ASI(AB).
- The matter was placed before BOC for decision.

DECISION- After discussion the Board members have accepted the prayers of C/508 Ashok Kumar Upadhyay of 1st IR Bn, DGP to forgo the promotion to the rank of ASI(AB). CO, 1st IR BN, DGP is requested to strictly follow the GO No-9120-F dtd-13/11/2000 of Finance Department, Audit Branch, Govt. of WB in this regard. The constable will not be entitled to any benefit under CAS 1990 and it should be recorded in his service book with an intimation to DIG (Administration), West Bengal.

- The Board also decided that the promotion order in respect of C/508 Ashok Kumar Upadhyay of 1st IR Bn, DGP to SAP 7th Bn as ASI(AB) will be placed before PEB for cancellation.

(viii) **Consideration of prayer regarding forgoing of promotion in respect of ASI/1711 Swapan Kumar Mondal and ASI/171 Parimal Ghosh of Hooghly (Rural) to the rank of SI(UB)-**

- ASI/1711 Swapan Kumar Mondal of Hooghly (Rural District) was declared fit for promotion to the rank of SI(UB) in the meeting of BOC for Examination and Promotion and subsequently he was posted on promotion to Chandannagar Police Commissionerate to the rank of SI(UB) vide this office memo no-1254(168)-Per/A // PER/A-27/2017 dtd-09/10/2018 [Sl. No-A. 48]. He submitted prayer expressing his unwillingness to take promotion to the rank of SI(UB) due to family problem and he also declared that he will never claim for the said promotion in future vide DO No-2935 dtd-18/12/2018 of SP, Hooghly (Rural).
- Another ASI/171 Parimal Ghosh of Hooghly (Rural) District was also declared fit for promotion to the rank of SI(UB) in the meeting of BOC for Examination and Promotion and subsequently he was posted on promotion to Chandannagar Police Commissionerate to the rank of SI(UB) vide this office memo no-883(168)-Per/A // PER/A-27/2017 dtd-27/07/2018 [Sl. No- A. 35]. He submitted prayer expressing his unwillingness to take promotion to the rank of SI(UB) due to the illness of his wife and he also declared that he will never claim for the said promotion in future vide DO No-2936 dtd-18/12/2018 of SP, Hooghly (Rural).
- Both the unwillingness prayers were forwarded by SP, Hooghly (Rural) under his memo no-1710/RO dtd-16/11/2018.
- The matter was placed before BOC for decision.

DECISION- After discussion the Board members have accepted the prayers of ASI/1711 Swapan Kumar Mondal and ASI/171 Parimal Ghosh of Hooghly (Rural) District to forgo the promotion to the rank of SI(UB). SP, Hooghly (Rural) District will be requested to strictly follow the GO No-9120-F dtd-13/11/2000 of Finance Department, Audit Branch, Govt. of WB in this regard. The ASIs will not be entitled to any benefit under CAS 1990 and it should be recorded in their service books with an intimation to DIG (Administration), West Bengal.

- The Board also decided that the promotion order in respect of ASI/1711 Swapan Kumar Mondal and ASI/171 Parimal Ghosh of Hooghly (Rural) District to Chandannagar Police Commissionerate as Si(UB) will be placed before PEB for cancellation.

(ix) **Promotion matter of C/1099 Biswajit Majumder of Paschim Medinipur for promotion to the rank of ASI (UB)-**

- SP, Paschim Medinipur has informed in his letter (vide his memo no-4411/RO dtd-12/12/2018), that C/1099 Biswajit Majumder passed PPT Course in batch no- 05/2015 for promotion to the rank of ASI (UB).

- His promotion matter was placed with others before Board of Control for Examination and Promotion held on 14/10/2015 and 09/07/2018 with the report of Length-Cum-Record of Service Board. Though he was fit as per record but due to pendency of a criminal case [vide Matigara PS case no-223/04 Dtd-18/08/2004 U/S 384 IPC (GR-750/04)], 'Sealed Cover' procedure was followed.
- SP, Paschim Medinipur has also forwarded the application of C/ Biswajit Majumder along with a copy of judgement order passed by Ld. JM 2nd Court, Siliguri on 01/09/2018, "that the accused person Biswajit Majumder is adjudicated as 'not guilty' and they are acquitted under section 248(1) of the Code of Criminal Procedure, 1973 from the charge under sections 384 of the Indian Penal Code. The accused persons are discharged from bail bonds. Alamat if any be destroyed when the period of appeal is over".
- The matter was placed before BOC for Exam. and Promotion for decision.

DECISION- As closed cover procedure was adopted in the BOC held on 14/10/2015 and 09/07/2018, the closed envelops have been opened. The members of the Board examined the matter and resolved that C/1099 Biswajit Majumder of Paschim Medinipur would be declared 'fit' w.e.f. 14/10/2015. C/1099 Biswajit Majumder of Paschim Medinipur is declared 'fit' for promotion to the rank of ASI(Unarmed Branch). He will get his promotional benefit in accordance with their immediate junior.

(x) **Rectification of caste of C/968 Sanjay Hansda of Siliguri Police Comm. for Promotion to the rank of ASI(UB)-**

- DCP(Headquarters), Siliguri Police Commissionerate informed vide his memo no-2676/RO dtd-11/12/2018, that C/968 Sanjay Hasda submitted a prayer for consideration of his promotion taking into account his caste i.e. Schedule Tribe. He also informed that on verification of available records along with service book it is revealed that he belongs to ST, but it was written as 'General Caste' at the time of Promotion Board by unintentional mistake.
- It is mentioned here that C/968 Sanjay Hasda secured 74 marks in the departmental examination for promotion to the rank of ASI(UB). Out of 1179 fit candidates all the ST candidates were promoted earlier. If C/968 Sanjay Hasda was considered as an ST candidate, he also would have been promoted earlier.
- The matter was placed before BOC for Exam. and Promotion for decision.

DECISION- The members of the Board examined the matter and resolved that the caste of C/ 968 Sanjay Hasda of Siliguri Police Commissionerate would be treated as 'Schedule Tribe' in place of 'General' and the Board also decided that his promotion order to the rank of ASI(UB) may be issued.
