Introduction of a system for awarding Police Medals for the State IPS Officers and Non-IPS officers in recognition of continuous outstanding service and devotion to duty was under active consideration of the Government for sometime past. After careful consideration of all aspect associated with the issue, the Governor has now been pleased to introduce a system of awarding the following Police Medals to the state IPS officers and Non-IPS officers in supersession of the notification no.45/Addl.Secy./DB/BMC/6M-8/2014 Dated.07.08.2014.

- (i) Chief Minister's Police Medal for Commendable Service.**
- (ii) Chief Minister's Police Medal for Outstanding Service.**

The award of medals shall be regulated as under:

(A) Chief Minister's Police Medal for Commendable Service.

- (i) Maximum number of medals to be awarded each year shall be eight between West Bengal Police and Kolkata Police.
- (ii) IPS(RR) Officers of West Bengal Cadre who have put in minimum of 8 years of service, SPS Officers with a minimum of 5 years of service in IPC and Non-IPS officers with a minimum of 15 years of service shall be selected for the medal.

(B) Chief Minister's Police Medal for Outstanding Service.

- (i) Maximum number of medals to be awarded each year shall be four between West Bengal Police and Kolkata Police.
- (ii) IPS(RR) Officers who have put in more than 15 years of service and SPS officers who have put in of 8 years of service in IPS or who had earlier received Chief Minister's Police Medal for Commendable Service shall be eligible for this medal.

In exceptional cases the Government may use its discretion to consider any officer for Chief Minister's Police Medal for Commendable Service beyond the above criteria.

General conditions and modalities for the award of the medals will be as follows:

1. Nomination from Zonal IGPs and CPs of Commissicnerate and Heads of other functional units shall be invited by DG & IGP, WB as per enclosed format (Annexure-A). Similar arrangement will be made by Commissioner of Police, Kolkata.
2. Officers with continued excellent service record and who have rendered outstanding public service will be nominated for these medals.
3. Officers who are on central deputation may not be nominated during the years of deputation.
4. Officers against whom departmental or criminal proceedings are pending shall not be nominated for award of medals.
5. Officers who have been awarded punishment may not be nominated for the award of medal.
6. Integrity Certificate of the concerned officer by the competent authority would be required for selection.
7. An officer who has been awarded a Medal for Commendable Service shall be eligible for a Medal for outstanding Service only after a minimum period of 5 years after being awarded the medal.

Method of Selection:

One committee each for West Bengal Police and Kolkata Police respectively comprising of the following officers will screen the nominations of the eligible candidates.

Such Committees shall consider nominations from West Bengal Police and Kolkata Police respectively and send the recommendations for award of medals to the State Government. Both the Committees will have the authority to include names of officers for consideration in addition to the nominations received from functional units.

Nomination of Award:

The names of awardees shall be published in the West Bengal Police Gazette and Kolkata Police Gazette. The scheme of this award will be deemed to have come into effect from 07.8.2014.
