The undersigned is directed to say that the Governor has been pleased to declare the i) Superintendent of Police, Ranaghat Police District ii) Superintendent of Police, Bongaon Police District and iii) Superintendent of Police, Islampur Police District as the Drawing and Disbursing Officers for all the Police Personnel in those districts and to declare them competent to draw and disburse funds and to perform all other duties, relevant and necessary for Drawing and Disbursing Officers in terms of T.R. 1.04(0), T.R. 4.028(2) and 4.028(5) of Treasury Rule 2005.

2. Undersigned is also directed to authorize Superintendent of Police, Krishnanagar Police District and Superintendent of Police, Raigunj Police District to use existing DDO codes which were earlier used by Superintendent of Police, Nadia Police District and Superintendent of Police, Uttar Dinajpur Police District respectively.

3. Superintendent of Police, Krishnanagar Police District, Superintendent of Police, Barasat Police District and Superintendent of Police, Raigunj Police District may also be permitted to act as DDO of newly created establishment mentioned at para-I above until allotment of new DDO codes are made available to the new DDO(s).
