- ii) A total of 1586 trainees (1577-Lady Recruit Constables & 09-Recruit Constables) joined for training at SVSPA and STCs in the month of February 2019.

iii) During the course of training at different training centres :-

- iv) 01(one) Lady Recruit Constable from STC SAP 4th Bn., submitted her resignation from service and was accepted by the Controlling Authority.
- v) 02(two) Lady Recruit Constables of STC SAP 9th Bn., and STC EFR 2nd Bn. respectively remained away from training for more than 25% of the training period and they have been reverted to next batch.
- vi) 02(two) Lady Recruit Constables of STC SAP 4th Bn., and STC EFR 2nd Bn. respectively have not been allowed to appear in the examination due to their absence from training for more than 15% of training duration.
- vii) 03 (three) Lady Recruit Constables of SVSPA and STCSPA 9th Bn. respectively did not qualify in different indoor subject.
- viii) A total of 1581 trainees (1572-Lady Recruit Constables & 09 Recruit Constables) appeared in the final examinations (Statement & list enclosed).
- ix) 1578 trainees (1569-Lady Recruit Constables and 09-Recruit Constables) have completely passed in all the indoor and outdoor subjects.

The result of the same is placed before the 'Board of Control for Training' for approval.

On discussion the Board resolved the following decision:-

- ▶ The Board approved the result of 1581 trainees (1572-Lady Recruit Constables & 09-Recruit Constables) of different STCs and SVSPA of which 1578 trainees (1569-Lady Recruit Constables and 09-Recruit Constables) have completely passed in the both indoor and outdoor subjects.
- ▶ 02(two) Lady Recruit Constables of STC SAP 9th Bn. & STC EFR 2nd Bn., respectively who remained away from training for more than 25% of training duration, will be reverted to the next batch. They will attend their basic training along with the next batch to be started shortly. DIG, Training / Principal, SVSPA, Barrackpore will inform the concerned units for basic training of batch reverted LRCs.
- ▶ Board resolved that, 02(two) Lady Recruit Constables of STC SAP 4th Bn., and STC EFR 2nd Bn. respectively who have not been allowed to appear in the final examination due to their absence over 15% of training duration, will be detained to undergo 30 days extended training at SVSPA, Barrackpore after the date of passing out parade. DIG, Training / Principal, SVSPA will arrange for their supplementary examinations.
- ▶ Board also resolved that, 03(three) Lady Recruit Constables of SVSPA and STC SAP 9th Bn., respectively did not qualify or did not appear in different indoor subjects, will also be detained to undergo 30 days extended training at SVSPA, Barrackpore after the date of passing out parade. DIG, Training / Principal, SVSPA will arrange for their supplementary examinations.

4. To examine the Result Sheet of the Supplementary Examination of 01-Detained RC of Batch No. 213/18-19.
