MINUTES OF THE MEETING OF THE 'BOARD OF CONTROL FOR TRAINING' HELD ON 28.09.2020 AT 16:00 HRS AT THE OFFICE CHAMBER OF ADDL. DIRECTOR GENERAL OF POLICE, TRAINING, WEST BENGAL, ARAKSHA BHAVAN, SALT LAKE CITY, KOLKATA-91.

Shri Soumen Mitra, IPS, Addl. Director General of Police, Training, West Bengal presided over the meeting.

#### Following members of the 'Board of Control for Training' attended the meeting:-

- 1. Shri K. Jayaraman, IPS, IGP (HQ-II), WB
- 2. Shri Dipankar Bhattacharyya, IPS, DIG/Principal, SVSPA, WB.

4. Shri Nilanjan Paul, WBCS (Exe.), Dy. Secretary, Home & Hill Affirs Dept., Govt. of WB

The following points were discussed in the meeting for taking decisions:-

- 1. Final Result of the Cadet SIs (UB & AB) for both Indoor & Outdoor Examinations.
- a) Cadet SI (UB) Batch Number 66/19-20
- b) Cadet SIs (AB) Batch Number 37/19-20
- c) Cadet SI (UB):- 1075 Reported. 28 Resigned including Cadet SI (UB)/762 Shaikh Ajmal Hossain. Three (3) were Batch-reverted for absence over 25% of the training period. Two (2) expired. One candidate could not appear in both Indoor & Outdoor Examinations because of Covid-19. Total 1041 candidates appeared in the Final Examination. Three candidates failed marginally in Paper-I. Seven (7) Candidates could not appear in Indoor Examinations only because of Covie-19. 1031 Candidates qualified in all Indoor & Outdoor examinations. (1031 + 7 + 3 + 1 + 2 + 3 + 28 = 1075)
- d) Cadet SI (AB): 303 Reported. Two (2) Resigned. Two candidates did not appear in Indoor Examinations because of absence owing to Covie-19. 299 candidates qualified in all Indoor & Outdoor examinations.
- 2. Revision of Syllabus of Junior Constables.
- 3. Revision of Syllabus of PPT course for Constables to the Rank of ASI (both UB & AB).
- 4. Forthcoming Training Commitments.
- 5. Discussion on the Syllabus for Trainee Dy. SPs in terms of Institutional Training and District Practical Training.

#### Decisions taken after thread-bare discussion:-

- 1. Matter relating to Cadet SIs (UB & AB).
- i) All the 1031 Cadet SIs (UB) Batch No. 66/19-20 who qualified in the Final Examinations for both Indoor & Outdoor Examinations have been declared as "Qualified' by the BOC.
- ii) Similarly 299 Cadet SIs (AB) Batch No. 37/19-20 have been declared "Qualified' by the BOC.
- Three Candidates of Cadet SIs (UB) Batch No. 66/19-20 who marginally failed in just one Indoor Subject (Paper-I) were given grace marks by BOC in tune with the provisions laid down in the Training Manual 2014 VOL-II [Ref:- Operational Guidelines for the BOC Training, Resolution No. 10 (Page No. 82), Cadet SI (UB)/321 Samrat Biswas got 38.5 marks, Cadet S( (UB)/432 Suvamoy Samanta Got 38 marks and Cadet SI (UB)/873 Bapi Dutta got 38.5 marks in Paper-I (Indoor) out of Pass Marks of 40. All three Candidates scored very close to Pass marks in Paper-I subject of Indoor Examination.

BOC has the power to give grace marks up to 4 (10% of 40=4) if a candidate scores marginally below 40 & not less than 36. But it is restricted to only two papers. As became all the three candidates failed marginally in only one paper & all three scored over 36 marks, BOC has the power to give Grace Marks only up to (Not above 40). Hence it was unanimously decided to raise the number of all three initially failed candidates to 40 (forty) in Paper-I (Indoor) & all three are hereby declared "Qualified"in Paper-I (Indoor) by BOC.

- iv) Cadet SI (UB)/762 Shaikh Ajmal Hossain, appointed by Bidhannagar Police Commissionerate, tendered his resignation in 20.09.2019. The matter is long pending with DIG(A), WB. Necessary pursuance will be made to resolve this long-pending issue. His resignation is required to be accepted formally as viewed by BOC.
- v) Oath-taking will be formally organized by each of the Police Units where Cadet SIs (UB & AB) were provisionally posted with intimation to SVSPA. The record of this Oath-taking will be formally maintained at SVSPA.
- vi) It is decided to maintain the system of conferring Medals/Prizes/Trophies to the toppers of this Cadet SIs Batches (UB & AB) at suitable time while keeping in mind the abnormal Covid-9 situation.
- vii) SVSPA will conduct supplementary examinations preferably within 30 working days (because of the **Puja intervention**) though as per Training Manual the permissible time-line has been set up to 90 days from the date of BOC. For eight Cadet SIs (UB) and two Cadet SIs (AB) who coud not appear in Final Examinations

(one for both Indoor & Outdoor and nine for only Indoor Examinations) because of Covid-19, necessary Supplementary Examinations will be organized by SVSPA within the time frame.

- 2. New revised syllabus for Junior Constables has been approved by BOC. This embraces more compact syllabus with **training duration of 90 days**.
- 3. New revised syllabus for PPT Courses in favour of Constables to the rank of ASI (UB & AB) with **training duration of 4 weeks B in** each case has been approved by BOC.
- 4. Forth coming Training Commitments:-
- i) New Batch (Batch No. 219) of RCs are expected to join SVSPA and other Training Units soon after immediately after the Puja, 2020. Possibly 4200 number of RCs will require accommodation, classroom and other Training requirements maintaining <u>Social Distancing</u>. In order to do this almost all the Training Infrastructure in all the Training Units in the State will be engaged.
- ii) The forthcoming Batch size of the Cadet SIs will be 668 as per available information. Accommodation, classrooms, instructions, etc. at SVSPA are to be kept ready for them.
- iii) DIG (Headquarter), WB will provide the necessary information with regard to the arrival of RCs and Cadet SIs. If the gap between their joining dates is one month or more, PPT Courses can be arranged **only by SVSPA** for six different categories of PPTS for **UB & AB for three Ranks.** As per instruction of PD, WB, this can be arranged at SVSPA. But all other Training Units will remain over-subscribed because of Basic Training of RCs of Batch number 219.
- Training Branch, WB will keep liaison with all the Training Centers (PTS+STCs+TTCs+NVF Training Centre Halisahar) apart from SVSPA, for **Capacity enhancement** and availability of space for additional number of trainees. Without enhanced capacity in all the Training Centres, the huge number of pending Candidates in three ranks (Plus the Categories of UB & AB) for PPT Courses cannot be cleared simultaneously. **Additional capacity building** is the **sine qua non** for solving this continuing shortcomings.
- v) All the Training Units in the States (PTS+STCs+TTCs+NVF Training Centre, Halisahar) are required to be reserved for only basic Training of RCs (Batch No. 219). Any other engagement will shrink the capacity further for the basic training of possible 4200 number of RCs maintaining Social Distancing. Training Branch, WB. will keep link with all those Training Units including AP, Headquarter to ensure this basic requirement.
- vi) It was noticed that the previous experience of long staggered Entry System of Cadet SIs and RCs. They joined in stages for almost five months (September 2019 to February 2020). It was very difficult to calculate Training Duration as well as to ensure equitable training period for each of the Cadet SIs and RCs. Long period of Continuous entry for basic training had many difficulties faced by SVSPA mainly for Cadet SIs. This time it was unanimously decided to maintain a cut-off date from the date of first and scheduled joining for both Cadet SIs & RCs. This cut-off date will be decided by PD, WB. The scheduled starting date for training will be suggested by Training branch, WB. Any Candidates after the cut-off date will be reverted to the Next Batch. This will be applicable for both Cadet SIs and Rcs.
- 5. **Revision of Syllabus for Dy. SP Trainees :-** Discussion has been suspended in this BOC. It will be discussed and decided in the next BOC for Training.

The 'Meeting' ended with a vote of thanks to and from the Chair.
