In case of expiry of Trade License during the period of 2019-2020, the renewed copy of the same should be produced at the time of starting work.

Corrections of the rate on the schedule, if any, should be authenticated by the Full signature of the Quotationer.

Right of acceptance of the Tenderer will rest with the undersigned that also reserves the right to reject or review or divide amongst the Tenderer without assigning any reasons thereof.

Similar penal measures shall also be initiated against those tenders who have submitted false / misleading / fraudulent documents or made incorrect declarations. The penal measure will be forfeiture of Earnest Money, Forfeiture of Performance Bank Guarantee if enlisted as a supplier.
