The rate should be either at par, below or above the estimate as given by the Executive Engineer (Zone-I), WBPH & IDCL & Asstt. Engineer, CLU, Latbagan, Barrackpore. The Tender should be submitted between 19/09/2019 to 25/09/2019 within 14:00 hrs in the Office Tender Box which will be opened on 26/09/2019 at 16:00 hrs. The tenderer's may remain present at the time opening of tender.

Time will remain unchanged. Successful tenderer will have to deposit Rs.9411/- as earnest money through in the form of NSC, Postal Order, KVP, OR THROUGH PORTAL, etc.

Copy of Original Clearance Certificates of Sales Tax/Income Tax Clearance Certificate/ Professional Tax, VAT, Trade License having validity up to the date of submission of quotation should invariably be furnished.

In case of expiry of Trade License during the period of 2019-2020, the renewed copy of the same should be produced at the time of starting work.

Corrections of the rate on the schedule, if any, should be authenticated by the Full signature of the Quotationer.

Right of acceptance of the Tenderer will rest with the undersigned that also reserves the right to reject or review or divide amongst the Tenderer without assigning any reasons thereof.

Tenderer's must fulfill the terms and condition, which may be obtained from the office of the undersigned.

Notes/ Bank Guarantee Bond/F.D.R. of any nationalized bank and to execute an agreement of contract within 7 (seven) days from the date of issue of the work order failing which the letter of acceptance, so issued, may be treated as cancelled as well as the earnest money so deposited may be forfeited and the firm may be blacklisted. Payment will be made as and when fund will be available from the concerned source subject to complete supply of articles.

Penalty Clauses :

PENALTY FOR FORMATION OF CARTEL OR FURNISHING OF FRAUDULENT / MISLEADING DOCUMENTS:

If during the quotation process or at any state during the validity of the tender period, it is found that a Quotationer(s) has formed a cartel in what so ever form or name to fix up the rates or suppliers to the detriment of the fairness of the tender process, penal measures shall be initiated. Similar penal measures shall also be initiated against those tenders who have submitted false / misleading / fraudulent documents or made incorrect declarations. The penal measure will be forfeiture of Earnest Money, Forfeiture of Performance Bank Guarantee if enlisted as a supplier.
