## TERMS AND CONDITION OF AUCTION SALE

- 1. The intending bidders must submit valid PAN, GST No., acknowledge receipt of payment of P.Tax, current trade license etc.
- 2. Reserve price for the unserviceable condemned Govt. spare parts, tyres, tubes & flaps has been fixed. The highest bidder will be considered on the basis of the reserve price fixed by competent authority and not on the basis of starting price.
