WHEREAS creation of two districts named as Darjeeling and Kalimpong by dividing the existing district of Darjeeling with effect from 14.02.2017 has been notified vide Notification No. 35-PAR(AR)/O/2R-2/16 dated 07.02.2017 and 36-PAR(AR)/O/2R-2/16 dated 07.02.2017 of the Department of Personnel & Administrative Reforms and e-Governance of the Government of West Bengal,

AND WHEREAS the undivided district of Darjeeling comprised of areas of Darjeeling Police District namely Darjeeling District and portion of Siliguri Police District namely Siliguri District (Siliguri Police Commissionerate).

NOW, THEREFORE, in exercise of the power conferred by section 2 of the Police Act, 1861 (5 of 1861) read with section 2 of the Bengal Police Act, 1869 (Ben. Act. VII of 1869), the Governor is pleased hereby to constitute two single police districts namely Kalimpong District and Darjeeling District by bifurcating Darjeeling Police District namely Darjeeling district, which was created vide Home (Police) Department Notification No. 4292-PL/PB/4P-27/11 dated 04.08.2012, having respective territorial jurisdiction as mentioned in the schedule below for the purposes of the Police Act, 1861 :-

Notification in respect of creation of two single Police districts named Kalimpong District and Darjeeling District, by bifurcating Darjeeling Police District namely Darjeeling District, has been issued vide No. 602-PL dated 13.02.2017 and published in Official Gazette on 14.02.2017. The Notification is in force w.e.f. 14.02.2017.
