Manbazar Sub-Division and Jhalda Sub-Division in Purulia District have been created vide Notification No. 100-AR/P/2R-2/1999 dated 30/03/2017 issued by Department of Personnel & Administrative Reforms and e-Governance. The notification is effective from 06/04/2017.

Accordingly, the post of Sub-Divisional Police Officer, Manbazar and Sub-Divisional Police Officer, Jhalda have been created vide No. 659-P.S.Cell dated 06/04/2017.

2) Now, the undersigned is directed to say that, the Governor after careful consideration of his proposal, has been pleased to create the following regular posts of different categories on temporary basis under West Bengal Police for a period of one year on the usual rate of pay and allowances for manning the office of the Sub-Divisional Police Officers (SDPOs), at Manbazar and Jhalda in the district Purulia.

- 5) The charge is debitable to the appropriate Head of Account in the State Police Budget.
