The undersigned is directed to refer to his Office Memo. No. 855-Org dated 25.07.2019 and to say that the proposal for merger of separate cadres of Constable and Lady Constable, ASI and Lady ASI, SI and Lady SI, Inspector and Lady Inspector in the Unarmed Branch of West Bengal Police into respective gender-neutral cadres, was under active consideration of the Government for some time past.

2.
