The said ASI did not complete the Pre/ Post promotional training course of constable for promotion to the rank of ASI(AB) and unfortunately he expired on 02.05.2021 due to sudden cardiac arrest, Covid Pneumonia and hypertension .

G.O. No.- 1640.PL/PB/14M- 24/19 dtd- 17.06.2019 of Home & Hill Affairs Department, it is said that the personal concerned shall be confirmed in higher rank and their inter-se – seniority will be fixed only after successful completion of PPT within stipulated period of two years from the date of provisional promotion. In case PPT is not completed within two years or before retirement on superannuation such officer shall automatically be reverted back to their lower rank unless allowed specifically by the Govt.

Under the above circumstances, CP, Chandannagar PC has requested to condon his post promotional training course of Constable to ASI (AB) also confirm his provisional promotion in the rank of ASI(AB) vide his office memo no.- 931/RO, CPC, Dtd- 13.05.2021 and CO No.- 1056 Dtd- 04.05.2021.

The matter was placed before B.O.C. for Examination and Promotion for decision.

**Decision:** The matter has been discussed by the members of the board. It is stated that the board is not competent authority for condon his post promotional training course of Constable to ASI (AB) also confirm his provisional promotion in the rank of ASI (AB). The matter was placed before B.O.C. for Examination and Promotion for decision.

**Decision:**
