The undersigned is directed to refer Memo No.1011-Org dated 15/12/2021 as mentioned above on the captioned subject and to say that the proposal for permanency of 939(Nine hundred thirty nine) temporary posts in different categories [Operational Staff-478, Administrative Support Staff – 120, Training Centre & Support Staff – 21, Medical Staff – 11, Communication Support Staff – 21, Motor Transport Staff – 61, Armour Staff Support – 04, Ministerial Staff – 06, Dog Squad – 19, The Special Intelligence Group – 198] of Counter Insurgency Force(CIF), West Bengal, created vide G.O. no.821-PL dt.02.03.2010 with concurrence of Finance Department vide their U.O. No.323-Gr. 'P'(Services) dt.01.02.2010, was under active consideration of the Government for some time past. These posts have been retained last upto 28.02.2019 in terms of G.O. No.2235-PL dtd.25.07.2018.

2. Now, in view of the fact of continuous retention of these posts for more than 03(three) years, the Governor is pleased to declare the aforesaid posts for Counter Insurgency Force(CIF), West Bengal as permanent with effect from 01.03.2019 in terms of Memo No.6059-F dated 25.06.1979 read with Memo No.3266-F(P), dated 18.04.2012 of Finance Department, Audit Br. Government of West Bengal.

3. The charge is debitable to the appropriate Head of Account in the State Police Budget.

4. This order issues with the approval of Additional Chief Secretary, Home & Hill Affairs Deptt., Govt. of West Bengal.

In cancellation of previous G.O. No.2170-PL/HP/N/PB/3P-18/10 dated 19.08.2021, the undersigned is directed to say that 593(five hundred ninety three) Posts (274 posts for 8 GRPS and 319 posts for 16 GRPS) of Siliguri G.R.P. District were created vide G.O. No.4448-PL/PB/3p-18/10 dtd.23/11/2010. Subsequently, out of aforesaid 593 posts, 02(two) posts of Inspectors, one each of New Mal GRPS and New Mayanaguri GRPS, were surrendered to create 02(two) posts of Inspectors, one each for Dumdum GRPS and Ballygaunge GRPS vide G.O. No.1586-PL dtd.25/03/2018. Remaining 591(five hundred ninety one) posts i.e. 272 posts for 8 GRPS and 319 posts for 16 GRPF in exclusion of 02(two) surrendered posts as detailed in Annexure 'A' (attached herewith) have been retained for more than three years with the approval of Finance Deptt. The last retention order was issued vide this Department Order No.3656-PL/PB/3P-18/10 dtd.26/08/2016 which expired on 05.01.2017. The reason for which the posts were created still exists.

Now, in view of the fact of continuous retention of posts for more than three years the Governor is hereby pleased to declare the aforesaid 591(five hundred ninety one) posts in exclusion of 02(two) surrendered posts as permanent with effect from 06.01.2017 in terms of Memo No.6059-F dated 25.06.1979 read with Memo No.3266-F(P) dated 18.04.2012 of Finance Department, Audit Branch, Government of West Bengal

MINUTES OF THE MEETING OF THE BOARD OF CONTROL FOR EXAMINATION AND PROMOTION HELD ON 31st March, 2022.

A meeting of the Board of Control for Examination and Promotion was held on 31st March 2022 at 12.00 hrs. in the DGP'S Conference Hall, at Bhabani Bhawan, Kolkata-27.

Dr. R. Sivakumar, IPS, Additional Director General & Inspector General of Police, Administration-II, West Bengal and Chairman of the Board presided over the meeting.

The following members of the Board attended the meeting-

1. Shri K. Jayaraman, IPS, ADG & IGP(HQ.), West Bengal.
2. Shri Debabrata Das, IPS, IGP, SVSPA, Barrackpore, West Bengal.
3. Shri Sheesh Ram Jhajharia, IPS, DIG(HQ), West Bengal, holding additional charge of DIG(P & W), West Bengal.

The following point was discussed in the meeting of BOC for Examination & Promotion.

(1) Consideration for promotion matter in respect of ASI(AB)-3236 Arup Ghosh of Howrah Rural District.

- DIG, Presidency Range has sent a letter vide his office Memo no. 209/FA-II dated 03.03.2022 received from Shri Gourav Halder, Advocate communicating there under contempt application CCP No.- 08/2022 , dated 22.02.2022 (Arising out of original application being O.A. No.- 547 of 2021) – Arup Ghosh – Applicant -Vs- 1. Sheesh Ram Jhajharia , IPS, DIG , Presidency Range 2. Smt. Krishnakali Lahiri, IPS, DIG(Planning & Welfare), WB holding the additional Charge of DIG(HQs.) , WB in c/w non- compliance of order dated 27.09.2021 in the matter of not considering the promotion -of- ASI(AB)-3236 Arup Ghosh of Howrah (Rural) District to the next higher post of SI(AB).
- It is also intimated that the next date of hearing has been fixed to be held on 01.04.2022 before the Honourable Administrative Tribunal.

- DIG(HQ), West Bengal has passed an Order vide his office memo no: 160(3)PER/A Dated: 29-03-2022 in this regard.
- On going through the office records, it is found that after scrutiny of Broad Sheets received from the respective Ranges, State wise Broad Sheet was prepared in which 103 officers were included for consideration of promotion of ASI(AB) to SI(AB). In that list of Broad Sheet the last i.e junior most officer was ASI(AB)-25 Bimal Rava whose date of officiation as ASI(AB) was 23-02-2011. However, the date of officiation of the applicant as ASI(AB) was 27-02-2011. For that reason the applicant could not come under the zone of consideration for departmental promotion to the rank of SI(AB) being junior to the last candidate as per date of officiation as ASI(AB).
- The official records further reveals that the Board of Consideration (BOC) for promotion of ASI(AB) to the rank of SI(AB) was held from 23-06-2021 to 28-06-2021 and the BOC declared 89 officers "FIT" for promotion to the rank of SI(AB) and the last "FIT " candidate i.e junior most as officiating ASI(AB) in the list is also ASI(AB)-25 Bimal Rava.
- The applicant ASI(AB)-3236 Arup Ghosh was given opportunity of appearing before the DIGP (HQ), WB for personal hearing. He attended for personal hearing and the DIGP (HQ), WB heard him personally on 29-03-2021. During personal hearing the ASI(AB) stated that ASI(AB) Debasish Bain of same batch had already got promotion to the rank of SI(AB). However, on scrutiny of office records it is found that ASI(AB)-76 Debasish Bain of DIG(AP),Cell, an SC category candidate, was considered " FIT" for promotion in the earlier BOC held in the year 2020 whose date of officiation as ASI(AB) was 11-02-2011. Therefore, said ASI(AB)-Debasish Bain is senior to the applicant in r/o date of officiation as ASI(AB).
- That having gone through the office record stated above, it has come to light that the applicant could not come under the zone of consideration for promotion to the rank of SI(AB) during the promotion Board(BOC held between 23-06-2021 to 28-06-2021) on question of seniority in r/o officiation as ASI(AB). Hence, at this stage, there is no scope of consideration of the applicant's case for departmental promotion to the rank SI(AB) in the light of judgement passed by the Hon'ble West Bengal Administrative Tribunal. However, the applicant's case for promotion to the

rank of SI(AB) in accordance with the prevailing rules may be considered in the next promotion board.

Decison: The Board members have accepted the reasoned order passed by the DIG(HQ), WB regarding promotion in r/o ASI(AB)-3236 Arup Ghosh of Howrah Rural District.
