**MINUTES OF THE MEETING OF THE BOARD OF CONTROL FOR EXAMINATION AND
PROMOTION HELD ON 07.06.2023**

A meeting of the Board of Control for Examination and Promotion was held on 07.06.2023 at 12:00 hrs. in the DGP'S Conference Hall, at Bhabani Bhaban, Kolkata-27.

Shri Ajey Mukund Ranade, IPS, Additional Director General & Inspector General of Police (Administration), West Bengal, the Chairman of the Board presided over the meeting.

The following members of the Board attended the meeting:-

1. Shri Sheesh Ram Jhajharia, IPS, Inspector General of Police (Administration) West Bengal.
2. Smt. Krishnakali Lahiri, IPS, Deputy Inspector General of Police, (P & W), West Bengal.
3. Shri Joy Biswas, IPS, Deputy Inspector General of Police (Provisioning), West Bengal.
4. Shri Amit Kumar Singh, IPS Vice Principal, SVSPA, Barrackpore in charge of IGP, SVSPA, BKP
5. Shri Sushil Kumar Dutta, Joint Secretary to the Govt. of West Bengal, Home and Hill Affairs Department.

The following points were discussed in the meeting of BOC for Examination & Promotion.

1. To examine and approve the result of the final examination of Pre-Promotional Training Course of Wireless Operators to the rank of supervisor Grade-II(Technical & Operational) of Batch No. 03/2023 and Supplementary Candidates of Batch No. 02/2022-23.

IGP, SVSPA, WB, Barrackpore has sent under memo no.- SVSPA / Exam Sec/PPT/WOPR/18(III)/2022-1579 dated 26.05.2023. The result of the Final Examination of Pre-Promotional Training Course of Wireless Operators to the rank of Supervisor Grade-II(Technical & Operational) of Batch No. 03/2023 commenced on and from 20/03/2023 at STC, Telecom (HQ), WB vide memo no. 608/P dated 02/03/2023 of DIG, Telecom, WB.

- Total 24(Twenty Four) Wireless Operator reported at STC, Telecom WB to undergo the aforesaid training and appeared in the final examination in all subjects and qualified successfully.

- 17 (seventeen) Wireless Operator of previous batch appeared as Supplementary Candidates of Batch No. 02/2022-23 in the examination in Paper-I (Basic Electricity) and all of them qualified successfully.
- The results of the same were placed before the 'Board of control for Examination and Promotion' for perusal and approval.

DECISION: The Board examined the result and approved of the same for next course of action. Total 41(Forty One) Wireless Operator have qualified the Pre-Promotional Training for promotion to the rank of Supervisor Grade-II(Technical & Operational).

2. To examine Length-Cum-Record of Service Book of 48(forty eight) Wireless Operator for promotion to the rank of Supervisor (Operational) Grade-II.

ADG & IGP, Telecommunication, WB, has sent under memo no.- 229/RO dated 30.05.2023, the L-C-R-S for promotion of Wireless Operator to the rank of Supervisor (Operational) Grade-II, of Telecom (HQ), WB.

- The Range Board for promotion of eligible 48(Forty Eight) Wireless Operator who have successfully completed Pre-Promotional Training w.e.f 07/11/2022 to 09/12/2022 for promotion to the rank of Supervisor (Operational) Grade-II, of Telecom (HQ), WB held on 30.05.2023 at Telecom(HQ), WB.
- Hence, the promotional Range Board of Telecommunication, WB declared 48(Forty Eight) Wireless Operator 'fit' for promotion to the rank of Supervisor (Operational) Grade-II, of Telecom (HQ), WB.
- At present there is 36(Thirty Six) vacancies in the rank of Supervisor (Operational) Grade-II, (Departmental Quota) of Telecom (HQ), WB.
- The L-C-R-S has been placed before the 'Board of control for Examination and Promotion' for perusal and approval.

DECISION: The Board examined the L-C-R-S and approved of the same for next course of action. Therefore, 36(Thirty Six) Wireless Operator are provisionally 'fit' for promotion to the rank of Supervisor (Operational) Grade-II of Telecom(HQ), WB. Competent authority of the Telecommunication, WB is directed to accord promotion to the next higher rank after observing all formalities as per existing rules including 50 point Roster.

3. Miscellaneous Correspondences.

SP Baruipur PD vide memo no. 911/RO dated 19/05/2023 intimated that Departmental Proceeding drawn up against Constable 251 Nirmal Kumar Bhunia who was under order of transfer on promotion to the rank of ASI(UB) but not taken Superior Charge.

- Constable 251 Nirmal Kumar Bhunia was under order of transfer to Jhargram dist. on promotion vide memo no. 145(85)/CRO//Per/A-86/2021 dated 31/03/2023 of IGP(A), WB. In the meantime, departmental proceeding was drawn up against Constable 251 Nirmal Kumar Bhunia vide Baruipur PD Proceeding no. 6/23 dated 18/04/2023 with the allegation of corruption. The charged Constable pleaded himself guilty to the charge. SP, Baruipur PD awarded him a major punishment and disposed off the departmental proceeding vide DO no. 1261 dated 28/04/2023.
- Now, the concerned SP has informed this matter for seeking opinion from this end for further action.
- The matter is placed before BOC (E&P) for decision.

DECISION: After perusal of records it is seen that Constable 251 Nirmal Kumar Bhunia of Baruipur PD was provisionally promoted to the rank of ASI(UB) and posted to Jhargram Dist. vide memo no. 145(85)/CRO//Per/A-86/2021 dated 31/03/2023. His name is in sl no. 198 of the said provisional promotion cum transfer order. He was accorded provisional promotion to the next higher rank as he was found "FIT" on that point of time. In the mean time, departmental proceeding was drawn up against him and final order has been passed in this respect and he is presently under currency of punishment. It is pertinent to mention here that vide memo no. 911/RO dated 19/05/2023 SP, Baruipur PD informed that the enquiry was ordered on 13/02/2023, way before the order of promotion i.e, on 31/03/2023 resulting to the instant proceeding. Hence, it is pre-contemplated issue and the Board unanimously decided to cancel the promotion order in respect of Constable 251 Nirmal Kumar Bhunia of Baruipur PD vide memo no. 145(85)/CRO//Per/A-86/2021 dated 31/03/2023

Considering the aspect the board unanimously decided the following:

- 1) The order of provisional promotion to the rank of ASI(UB) in respect of Constable 251 Nirmal Kumar Bhunia of Baruipur PD vide memo no. 145(85)/CRO//Per/A-86/2021 dated 31/03/2023 is hereby treated as cancelled.
- 2) The Board unanimously declared him "unfit" as he is under currency of punishment.

- 3) SP, Baruipur PD shall incorporate the instant decision in the service book of the incumbent.

**MINUTES OF THE MEETING OF BOC FOR TRAINING HELD ON 22.06.2023 AT 12:30 HRS.
AT THE OFFICE CHAMBER OF ADGP & IGP, TRAINING, WB, SALT LAKE, KOLKATA.**

Smt. Damayanti Sen, IPS, Additional Director General of Police, Training, West Bengal presided over the meeting.

The following officers of the 'Board of Control for Training' also attended the meeting:-

1. In pursuance to Memo. No. 159/CORD CELL/ELECT dated 21.06.2013, all the newly recruited constables of West Bengal Police are required to be trained in use of arms, gas musketry and riot drills for deployment in the ensuing Panchayat General Elections. The basic training of RCs is scheduled to commence on and from 24.06.2023. In compliance with the above order, a special training module of one week regarding the basic training of upcoming Recruit Constables at different STCs & TTCs of the State has been prepared by IG SVSPA which was put up before the Board. The Board considered the syllabus and discussed in details. All members put forward their suggestion. Board consented that IGP, SVSPA should make necessary changes as suggested by members.
2. IG SVSPA informed the Board that total 68 Wireless Supervisors (Grade II) have joined SVSPA for 4 months basic training. IG SVSPA proposed that papers for indoor examinations may be set by the outside faculty as is the convention followed for regular Cadets.
3. IG SVSPA placed the results of recently concluded final examination of Excise Recruit Constables, Batch no. 2/2023 before the Board for ex-post facto approval. Out of 647 ERCs who had appeared in the examination, 647 completely passed the in all subjects while. One candidate of Batch No. 1 who had appeared for supplementary examination also passed in all subjects. BoC approved the results.
4. IG SVSPA also placed the results of Junior RCs batch no. 11/2023 who were trained at STC 7th Bn., Asansol for ex-post facto approval. Out of 200 JRCs who had appeared in the examination, all have completely passed in all subjects. One JRC was batch revered for long absence.
