Dated 10.08.2023

In order to ensure better traffic management and enforcement of traffic rules, the functioning of traffic police in Ranaghat Police district needs to be reorganized by setting up of required number of Traffic Guards in the district. It is also necessary to specify the area of responsibility of each of the Traffic Guards with respective jurisdiction.
