In exercise of the power conferred by sub-clause (c) and (d) of clause (8) of section 2 of the Official Secr3ets Act, 1923 (19 of 1923), read with Government of India Notification bearing No. SO 3320, dated the 16th September, 1967 published in the Gazette of India, 1967 Part-II, Section 3(ii), Page 3394, the Governor on consideration of the fact that information with respect to the places mentioned in the column (1) of the Schedule below or damage thereto or the destruction or obstruction thereof, or interference therewith, would be useful to an enemy, is hereby pleased to declare the said places to be prohibited places for the purposes of the said Act.

A meeting of the Board of Control for Examination and Promotion was held on 13.12.2023 at 12:00 hrs. in the DGP'S Conference Hall, at Bhabani Bhaban, Kolkata-27.

The following points were discussed in the meeting of BOC for Examination & Promotion.

- To examine Length-Cum-Record of Service of 31(thirty one) Supervisor (operational) Grade-II for promotion to the rank of Supervisor (operational) Grade-I in West Bengal Police Telecommunication Branch.
 - DG & IGP, Telecommunication, WB, has sent memo no.- 428/RO dated 04.12.2023, containing the L-C-R-S for promotion of Supervisor (operational) Grade-II to the rank of Supervisor (operational) Grade-I of Telecom (HQ), WB.
 - The Range Board for promotion of eligible 31 (thirty one) Supervisor (operational) Grade-II was held on 01.12.2023 at Telecom(HQ), WB, for promotion to the rank of Supervisor (operational) Grade-I, of Telecom (HQ), WB and all 31(thirty one) were declared provisionally "fit" for promotion to the next higher rank.
 - At present(as on 01.12.2023), there is 15(fifteen) vacancies in the rank of Supervisor (operational) Grade-I, of Telecom (HQ), WB.
 - ➤ The L-C-R-S has been placed before the 'Board of control for Examination and Promotion' for perusal and approval.

DECISION: The Board examined the L-C-R-S and approved of the same for next course of action. Therefore, 31(thirty one) Supervisor (operational) Grade-II are provisionally 'fit' for promotion to the rank of Supervisor (operational) Grade-I of Telecom(HQ), WB. Competent authority of the Telecommunication, WB is directed to accord promotion to the next higher rank after observing all formalities as per existing rules including 50 point Roster.

It has been observed that no PPT or any kind of training/ refresher course is conducted before according the said promotion.

It is desirable to conduct 2 (two) week refresher course for newly promoted Supervisor (operational) Gr.-I in Telecommunication Branch of WBP in consultation with IGP, SVSPA, Barrackpore.

Henceforth, before granting promotion from Supervisor (Operational) Grade-II to Supervisor (Operational) Grade-I, a two (02) week refresher course be conducted. Training syllabus be designed by Telecommunication, WB in consultation with IGP, SVSPA, Barrackpore and be placed before BOC(Training) for approval.
