### **MEMORANDUM**

Subject: Standard operating procedure (SOP) for Ad-hoc family pension

The simplification of procedures to regulate early disposal of Ad-hoc Family Pension cases has been under active consideration of the Government.

The Governor is now pleased to lay down the following standard operating procedure to be followed by various authorities for settlement of Ad-hoc family pension claims of family pensioners of deceased Government employees.

## A. Procedure to be followed by the claimant

The claimant shall apply to the office where the deceased Govt. employee was last serving. The claimant shall submit as enclosure the following documents:-

## (a) In case of Ad-hoc Family Pension claimed by the spouse:

- I. Marriage Registration Certificate/documents relating to service record etc.
- II. Annexure A & B in terms of G.O. No. 11585-F dated 19.10.1987.
- III. Attested copy of Aadhaar Card Voter Card and PAN Card.
- IV. Recent Passport Size Photograph, Specimen Signature, Annexure 'A', Bank details and Descriptive Roll duly attested (four copy each).
- V. An original affidavit made by the claimant, before Ld. 1st Class Magistrate to the effect that there is no other recipient of family pension, other than the claimant.
- VI. Death certificate of the deceased employee.
- VII. Attested copy of P.P.O. of the deceased Govt. employee.

## (b) In case of Ad-hoc Family Pension claimed by un married/divorces/widowed daughters of the deceased employee:

- I. Annexure X & Y in terms of G.O. No. 740-F(Pen) dated 12.11.2008.
- II. Attested copy of Aadhaar Card Voter Card and PAN Card.
- III. An original current Income Certificate from a Group A Officer.
- IV. Recent Passport Size Photograph, Specimen Signature, Annexure 'A', Bank details and Descriptive Roll duly attested (four copy each).
- V. An original affidavit made by the claimant, before Ld. 1st Class Magistrate to the effect that there is no other recipient of family pension, e.g. minor son/daughter, physically handicapped son/daughter in the family, other than her.

- VI. Attested copy of P.P.O. of the deceased Govt. employee/deceased family pensioner.
- VII. Death certificate of father & mother of the claimant.
- VIII. Death certificate of the husband, in case of the widowed daughter.
- IX. Attested copy of the decree of divorce, in case of divorced daughter.

## B. Procedure to be followed by the Head of Office

If any reference of P.P.O./Bank details is readily available to show that the deceased pensioner was getting regular pension and the authenticity of the PPO is established, no further need of verification of PPO is required and the Head of Office (HoO) shall forward the case to the PSA not later than 14 days from the date of receipt of the claim.

#### If not.

The family pension case may be taken up with the Pr. A.G.(A&E), W.B. for the purpose of verification of P.P.O. within 2 weeks and verification of PPO is to be done from the end of the Pr. A.G.(A&E), W.B. within 3 weeks and if verified to be OK by the Pr. AH(A&E), the HoO shall forward the case to the PSA

## C. Procedure to be followed by the PSA

The PSA, on receipt of the furnished documents from the HoO, shall examine the case and after being satisfied will issue a sanction order in favour of the claimant within 2 weeks of receipt of the same from the Head of Office. Thereafter the matter shall be forwarded to the Principal Accountant General (A&E), West Bengal.

## D. Procedure to be followed by the Pr. A.G. (A&E), WB

The Pr. A.G.(A&E), WB, shall process the claim of ad hoc family pension and issue Family Pension Payment Order (FPPO) in favour of the claimant subject to the fulfilment of necessary criteria.

## Minutes of the meeting of BoC for Training held on 05.03.2024 at 12:00 hrs. at the office chamber of ADGP & IGP, Training, WB, Salt Lake, Kolkata.

Smt. Damayanti Sen, IPS, Additional Director General & Inspector General of Police, Training, West Bengal presided over the meeting.

The following officers of the 'Board of Control for Training' also attended the meeting:-

- 2. Shri Rishikesh Meena, IPS, IGP (O), WB holding addl. charge of IGP(A), WB.
- 3. Shri Ujjwal Kumar Bhowmick, IPS, Dy. Inspr. General of Police, PTS, Salua.
- 4. Shri Rashid Munir Khan, IPS, DIG, HQ, WB.
- 5. Shri Dipanjan De, Sr. Deputy Secretary, Home and Hill Affairs Dept., Govt. of WB.

Following points were submitted for the discussion and decision there upon by the Board:

- 1. Approval of the final result of detained Recruit Constables of Batch No. 224/2023-2024.
- > The result sheet of final examination of 15 detained Recruit Constables of Batch No. 224/2023-2024 was placed before the members of the Board. 15 detained RCs appeared in the Supplementary Examination and have completely passed in all indoor and outdoor subjects. Board unanimously approved the result.
- 2. Revision of syllabus of Cadet SIs (UB) batch no. 69/2023-24 and Cadet SIs (AB) batch No. 40/2023-24 (New Batch) in view of notification of New Criminal Laws
- ➤ In view of the notification of New Criminal Laws which are to come into effect from 1<sup>st</sup> July, 2024, IGP SVSPA proposed that the corresponding syllabus of criminal major acts for ongoing training of Cadet SIs may be revised by replacing the corresponding provisions of 3 New Criminal Laws i.e. Bharatiya Nyaya Sanhita, 2023, Bharatiya Nagarik Suraksha Sanhita, 2023 and Bharatiya Sakshya Adhiniyam 2023. Board members deliberated upon the same and it was decided that, henceforth, further training of cadet SIs (new batch) may be conducted as per new criminal laws and IGP SVSPA will put up revised syllabus for approval of BoC in the next meeting.
  - 3. Modular course for Cadet SIs (UB) batch No. 68/2023-24 and Cadet SIs (AB) batch No. 39/2023-24 (Old Batch) in view of notification of New Criminal Laws.
  - ➤ IGP, SVSPA, informed that basic training of old cadet batch has been nearly completed. 02 weeks Modular Course on the New Criminal Laws has been drafted for the old batch of Cadet SIs (UB) and (AB) for familiarization of New Criminal Laws. The modular course will be conducted after the final examination and training period extended to

that extent. The draft has been placed before the Board members and the Board unanimously approved the same. Board also directed that one class per day can be organized for orientation of new criminal laws before examination.

- 4. Revision of syllabus of Dy. SP (U/T) of batch No. 71/2023-24 in view of notification of New Criminal Laws.
- ➤ Revision of syllabus of Dy. SP (U/T) was also discussed along the lines of discussion for Cadet SIs (new batch). Board members decided that, henceforth, further training of Dy. SP (U/T) may be conducted as per new criminal laws and IGP SVSPA will put up revised syllabus for approval of BoC in the next meeting.

## 5. Miscellaneous:

- ➢ BoC also resolved that training of new RCs (including those of Kolkata Police) should henceforth be conducted as per new criminal laws. Further, an orientation programme of 07 days may be conducted for RCs currently undergoing training at STC Barjora and TTC SAP 7<sup>th</sup> Bn.
- ➤ In Miscellaneous agenda, a point raised to the effect that, external paper setters are often not complying with the orders from Police Directorate and are returning the letters regarding setting u p of question papers which makes it impossible for the SVSPA examination cell to conduct the examinations as per schedule. Board decided that PD may be requested to make setting up of question papers mandatory for senior officers whose names have been approved by PD. Board also asked IGP SVSPA to keep one paper setter in reserve category for each question paper.

## GOVERNMENT OF WEST BENGAL, Home & Hill Affairs Department Police Establishment Branch,

#### **NOTIFICATION**

No. 319-PL/PB/14M-47/23 Dated 12.02.2024 – In exercise of the power conferred by section 2A of the Police Act, 1861 (5 of 1861) and in supersession of all previous rules on the subject, the Governor is pleased hereby to make the following rules for regulating the recruitment to the posts of Sub-Inspector (Unarmed Branch) and Sub-Inspector (Armed Branch) in the West Bengal Police under the Home and Hill Affairs Department, Government of West Bengal:-

#### Rules

- 1. Short title and commencement (a) These rules may be called the Sub-Inspector (Unarmed Branch) and Sub-Inspector (Armed Branch) in the West Bengal Police Combined Recruitment Rules, 2024.
- (b) These rules shall come into effect on and from the date of their publication in the Official Gazette.
- **2. Definitions** In these rules, unless the context otherwise requires
  - (a) "Board" means the West Bengal Police Recruitment Board;
  - (b) "Directorate" means the West Bengal Police Directorate;
  - (c) "Government" means the State Government of West Bengal;
  - (d) "Transgender person" means a transgender person as defined in clause (k) of section 2 of the Transgender Persons (Protection of Rights) Act, 2019 (40 of 2019).
- **3. Recruiting Agency** Direct Recruitment (by selection) to the posts of Sub-Inspector (Unarmed Branch) and Sub-Inspector (Armed Branch) in the West Bengal Police shall be made through the West Bengal Police Recruitment Board. The Board shall always invite applications from eligible candidates through open advertisement.
- **4. Method of Recruitment** The posts of Sub-Inspector (Unarmed Branch) and Sub-Inspector (Armed Branch) shall be filled up by direct recruitment (by selection) and by promotion from amongst the eligible candidates in the following manner:-

(a) 50% of the posts to be filled up by selection (direct recruitment) on the basis of qualifying the Preliminary Examination followed by the Physical Measurement Test, Physical Efficiency Test, Final Combined Competitive Examination and Personality Test to be conducted by the Board as stated in rule 8.

Provided that a maximum of 10% of total vacancies in the direct recruitment quota (i.e. 10% of 50% referred in this rule) may be filled up through a limited departmental examination to be conducted by the Board, from the serving Constables and Assistant Sub-Inspectors of Police having requisite qualifications and having completed three years of continuous and satisfactory service in West Bengal Police. This method of limited departmental examination shall be used in exceptional and special circumstances only and not as a matter of routine and is subject to the prior approval of the Government.

- (b) 50% of the posts to be filled up by promotion following the extant Government rul34es and orders in this respect.
- **5. Eligibility Criteria for Direct Recruitment** The eligibility criteria for the posts of Sub-Inspector (Unarmed Branch) and Sub-Inspector (Armed Branch) in the West Bengal Police shall be as follows:-
- (a) The candidate must be a citizen of India;
- (b) The candidate must have a bachelor's degree in any discipline from a recognised university or its equivalent;
- (c) The applicant must be able to speak, read and write Bengali Language. However, this provision will not be applicable to the persons who are permanent residents of hill sub-divisions of Darjeeling and Kalimpong districts:

Provided that for the applicants of hill sub-divisions of Darjeeling and Kalimpong district, the provisions laid down in the West Bengal Official language Act, 1961, will be applicable;

(d) Age of the candidate must not be less than 20 years and not more than 30 years on the 1<sup>st</sup> day of January of the year of advertisement:

Provided that the upper age-limit shall be relaxable by five (5) years in case of Scheduled Castes and Scheduled Tribes candidates, and by three (3) years in the case of Other Backward Classes – A and Other Backward Classes – B candidates, and by three (3) years in the case of transgender persons;

- (e) The upper age-limit for the departmental candidates shall be 35 years. The upper age-limit shall be relaxed by five (5) years in case of Scheduled Castes and Scheduled Tribes candidates, and by three (3) years in the case of Other Backward Classes-A, and Other Backward Classes-B candidates, and by three (3) years in the case of transgender persons;
- (f) Male and female candidates and transgender persons are eligible to apply for the posts;
- (g) The candidates must have minimum physical measurements and qualify the physical efficiency test as laid down in rules 6 and 7;
- (h) The departmental candidates having requisite qualifications are eligible to apply for direct recruitment;

Provided that no departmental candidates shall be allowed to appear in the competitive examination for direct recruitment and limited departmental examination, as the case may be, for more than three times taken together.

- **6. Physical Measurement Test (PMT)** All those candidates who have qualified Preliminary Examination will be called for Physical Measurement Test. The minimum physical measurements for the posts of Sub-Inspector under West Bengal Police shall be as follows:-

- **8. Plan of Examination** Competitive examination and Tests for the recruitment to the posts of Sub-Inspector (Unarmed Branch) and Sub-Inspector (Armed Branch) in the West Bengal Police shall be held as follows:
  - (a) Preliminary Examination: The preliminary examination will be held on General Studies, Logical and Analytical Reasoning and Arithmetic (Multiple Choice objective type questions) with full marks of 200 (100 marks in General Studies having 50 questions, 50 marks in Logical and Analytical Reasoning having 25 questions and 50 marks in Arithmetic having 25 questions) and the duration of the preliminary examination shall be of 90 minutes. The preliminary examination will be a screening test for selection of candidates for the Physical Measurement Test and Physical Efficiency Test. The Board will be the competent authority to determine

minimum cut-off marks for each category and post taking into account the number of vacancies proposed to be filled up in each category and post.

The marks obtained by the candidate in Preliminary examination will not be counted for the purpose of determining the final merit list.

The syllabus for Preliminary examination shall be as mentioned in the Appendix.

**Explanation** – For limited departmental examination as referred in the proviso to sub-rule (a) of rule 4, no Preliminary examination will be held.

- (b) Physical Measurement Test (PMT) and Physical Efficiency Test (PET): The Physical Measurement Tests (PMT), as specified in rule 6, relating to the height, weight and chest of the candidates qualified in the preliminary examination shall be taken followed by the Physical Efficiency Test (PET) of the eligible candidates as specified in rule 7. Only those candidates who have qualified in PMT will be eligible to appear in PET. These tests shall be conducted by the Board at the venues selected by the Board for the purpose. Only the candidates who qualify both PMT and PET shall be eligible to appear in the final combined competitive examination.
- **(c) Final Combined Competitive Examination :-** The Final Combined Competitive Examination will consist of three (3) papers of conventional types of questions, namely:-
  - (i) Paper-I: General Studies and Arithmetic for 100 marks (50 marks for General Studies, 25 Marks for Logical and Analytical Reasoning and 25 marks for Arithmetic) of two hours' duration.
  - (ii) Paper-II: English for 50 marks of one hour's duration.
  - (iii) Paper-III:-Bengali/Hindi/Urdu/Nepali for 50 marks of one hour's duration.

The written examination for all these three papers of the Final Combined Competitive Examination shall be held on the same day at selected centres to be decided by the Board. The syllabus for Final Combined Competitive Examination shall be as mentioned in the Appendix to these rules.

### (d) **Personality Test**: Full Marks – 30.

The Board shall have the discretion to fix qualifying marks in all or any of the three papers and also in the aggregate of three papers in the Final Combined Competitive Examination. A limited number of the candidates who have fulfilled all the eligibility criteria for the post will be selected merit-wise on the basis of the results of the final combined Competitive Examination and will be called to appear at the Personality Test. The minimum passing mark for the Personality Test will be 08. The candidates who have failed to secure minimum passing mark in the Personality Test will be disqualified.

The Final Merit List of provisionally selected candidates shall be prepared on the basis of the total marks obtained in the three papers of Final Combined Competitive Examination and the marks obtained in the Personality Test. The candidates who have failed to secure minimum passing mark in the Personality Test will not be considered for selection.

- 9. Choice of posts in order of preference The candidate shall be required to indicate their choice of posts among the Sub-Inspector (Unarmed Branch) and Sub-Inspector (Armed Branch) in order of preference at the time of submission of application. Such choice of posts shall be deemed to be final and shall be taken into consideration for the purpose of recommendation for appointment after selection by direct recruitment.
- **10.** Reservation of Posts The reservation of posts for Scheduled Castes, Scheduled Tribes, Other Backward Classes-A, Other Backward Classes-B and Economically Weaker Sections categories shall be as per extant rules/orders issued by the State Government from time to time.
- 11. Verification of Character Antecedents All provisionally selected candidates shall be required to fill up a Verification Roll which shall be thoroughly enquired into by the concerned authority.

- **Medical Examination** All provisionally selected candidates shall be required to appear for medical examination at the hospitals designated by the State Government for the purpose. The candidate should qualify the prescribed Medical Test. The candidates must not have knock knee, flat foot, varicose vein and squint eyes. The minimum vision should be 6/6 with or without glasses. They should possess high colour vision and should not be colour blind. The medical test shall also include the chest x-ray and other tests as prescribed by the Department of Health and Family Welfare, Government of West Bengal, from time to time. The selected candidate should be in good mental and physical health and free from any physical deformity and disability likely to interfere with the training and efficient performance with the duties as Police officer. The certificate of fitness shall be issued by the authorised Medical Officer.
- 13. Appointment and Probation The appointment, Probation and Confirmation to these posts shall be guided by the West Bengal Services (Appointment, Probation and Confirmation) Rules, 1979. The following provision shall also be applicable:-\
- (a) The candidates provisionally selected for appointment to the posts of Sub-Inspector (Unarmed Branch) and Sub-Inspector (Armed Branch) shall, after successful completion of Verification of Character Antecedents and Medical Examination, be appointed on temporary basis. After successful completion of Basic Training, they will be placed on probation for two years;
- (b) The candidates who have taken Hindi/Urdu/Nepali as a subject in Paper-III and selected for any of the posts under this combined competitive examination, shall be required to pass a departmental examination in Bengali as specified in the West Bengal Services (Training and Examination) Rules, 1953, read with provisions of the West Bengal Services (Compulsory Requirement of Knowledge in Bengali for recruitment to any post or Service) Rules, 2002, during the period of probation for confirmation in the post.
- **14. Training and Examination** The candidates selected for appointment to the posts of Sub-Inspector (Unarmed Branch) and Sub-Inspector (Armed Branch) shall undergo a course of training in accordance with the Police Regulations, Bengal and Training Manual and /or such rules and regulations for the time being in force. They shall also be required to pass out of Swami Vivekananda State Police Academy, Subsidiary Training Centre, Police Training School or any other institute designated for the purpose, as the case may be, after having undergone a prescribed course of training.
- **15. Appointing Authority** Assistant Inspector General of Police or Superintendent of Police or Commandant, as the case may be, shall be the appointing authority in respect of Sub-Inspector (Unarmed Branch) and Sub-Inspector (Armed Branch) in West Bengal Police.
- **16. Discharge** (a) A Sub-Inspector of Police (Unarmed Branch or Armed Branch) in West Bengal Police while undergoing basic training at Swami Vivekananda State Police Academy, Police Training School or any Subsidiary Training Centre is liable to be discharged if he/she is found unsuitable for the post by the Principal/Vice-Principal of the State Police Academy/Police Training School/Subsidiary Training Centre (not below the rank of Superintendent of Police) as the case may be .
- (b) The order of discharge shall include the grounds of discharge, but no formal proceeding shall be necessary.
- (c) The order of discharge shall not be given effect to until its confirmation by the next higher authority.
- (d) No appeal shall lie against the order of discharge.
- 17. Overriding Provision The provision of these rules shall have effect notwithstanding anything to the country contained elsewhere in any other rules or regulations for the time being in force, regulating the recruitment to the posts mentioned in these rules.
- 18. Repeal and Saving Notwithstanding anything contained in these rules, the persons appointed on regular basis or substantively to the posts covered under these rules prior to coming into force of these rules shall be deemed to have been appointed under these rules.

## **Syllabus for the Examination**

1. Preliminary Examination and Paper I of the Final Combined Competitive Examination.

## General Studies and Arithmetic:-

- (a) General Studies: Questions will be set to test the General Knowledge of candidate in different spheres;
- (b) Logical and Analytical Reasoning : Questions will be sent to test the logical and analytical ability of the candidate;
- (c) Arithmetic: Questions will be set on the basis of syllabus of Madhyamik Examination of the West Bengal Board of Secondary Education.
- 2. Paper II and Paper III of the Final Combined Competitive Examination:

Paper II – English – Questions may be asked on all or any of the following items :

- (a) Drafting of a report from the points or materials supplied;
- (b) Translation from Bengali/Hindi/Urdu/Nepali, as the case may be, to English;
- (c) Condensing of a prose passage (summary/précis);
- (d) Correct use of works, correction of sentences, use of common phrases, synonyms and antonyms.

## Paper III - Bengali/Hindi/Urdu/Nepali: Questions may be asked on all or any of the following items;

- (a) Drafting of a report from the points or materials supplied;
- (b) Translation from English to Bengali and English to Nepali for the candidates who have opted for 'Bengali' and 'Nepali' respectively and translation from Hindi/Urdu to Bengali for the candidates who have opted for Hindi/Urdu.

#### Rules

- 1. Short title, application and commencement (1) These rules may be called the West Bengal Police (Recruitment of Constables) Rules, 2024.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- (3) They shall apply for recruitment to the posts of Constable by the Appropriate authority of West Bengal Police Directorate throughout the jurisdiction of West Bengal Police under the Police Act, 1861.
- 2. **Definitions** (I) In these rules, unless the context otherwise requires –
- (i) "the Act" means the Police Act, 1861 (5 of 1861);
- (ii) "Appropriate authority" means the Appropriate authority as may be appointed by the State Government;
- (iii) "Board" means the West Bengal Police Recruitment Board;
- (iv) "Department" means the Department of Home and Hill Affairs, Government of West Bengal;
- (v) "Directorate" means the West Bengal Police Directorate under the Department;
- (vi) "Government" means the State Government of West Bengal;
- (vii) "Third Gender" means a transgender person as defined in clause (k) of section 2 of the Transgender Persons (Protection of Rights) Act, 2019 (40 of 2019).
- (2) Words and expressions not defined herein but defined in the Act, shall be deemed to have the same meaning as respectively assigned to them in the Act.

**3. Recruitment Authority** – (1) The Recruitment to the post of Constables in the West Bengal Police shall be made by the appropriate authority of the Directorate on the basis of recommendations of the Board. The Board shall always invite applications from eligible candidates through advertisement;

Provided that appointment on compassionate ground under Exempted Category shall be excluded from the purview of the Board. Such Appointments shall be done by the appropriate authority of the Directorate as per the scheme of the Labour Department, and with prior approval of the Government.

- 4. Eligibility—The eligibility criteria of candidates applying for the posts of Constables shall be as follows:
- (a) the applicant must be a citizen of India;
- (b) Male, female and Third Gender candidates are eligible to apply for the post of Constables;
- (c) Age: The applicant must not be less than 18 (eighteen) years old and must not be more than 30 (thirty) years old on 1<sup>st</sup> day of January of the year of the advertisement for the recruitment;

Provided that the upper age-limit shall be relaxable by five (5) years in case of Scheduled Castes and Scheduled Tribes candidates, by three (3) years in the case of Other Backward Classes – A and Other Backward Classes – B candidates, by three (3) years in case of Third Gender persons and by 5 (five) years in case of Civic Volunteers/Village Police Volunteers;

Provided further that the upper age-limit for the ex-Serviceman candidates shall be relaxed by the total number of years of completed service as Serviceman subject to maximum age of 40 (forty) years;

- (d) Educational qualification: The applicant must have passed Madhyamik Examination from the West Bengal Board of Secondary Education on its equivalent examination;
- (e) Language: (i) The applicant must be able to speak, read and write Bengali Language;

Provided that this provision will not be applicable to the persons who are permanent residents of hill subdivisions of Darjeeling and Kalimpong Districts.

- (ii) For the applicants of hill sub-divisions of Darjeeling and Kalimpong Districts, the provisions laid down in the West Bengal Official Language Act, 1961 (24 of 1961) shall be applicable;
- (f) The candidates must have minimum physical measurements and qualify the physical efficiency test as laid down in rule 5;
- (g) Additional eligibility criteria for candidates under sports quota :
  - (i) only the disciplines and the sports events organized by the School Games Federation of India, the Association of Indian Universities, Sports Authority of India and Indian Olympic Association at national level will be considered under this quota,
  - (ii) in case of individual events, participation and securing up to 8<sup>th</sup> position,
  - (iii) in case of team event, participation at lease upto semi-final stage.
  - (iv) players who represented India at International level, irrespective of the position secured by them.
  - (v) participation as above within 03 years as on 1<sup>st</sup> January of the year of the advertisement for the recruitment shall be considered.
- **5. Method of Recruitment** The posts of Constable in the West Bengal Police shall be filled up on the basis of Written Examination followed by Physical Measurement Test (PMT), Physical Efficiency Test (PET) and Interview.
- (a) Written Examination (Maximum Marks: 85):-

Applicants provisionally considered eligible will be called for the Written Examination. The Written Examination will be OMR based and in MCQ pattern. The duration of the Written Examination will be one (1) hour. The Scheme, Syllabus, Date and Venue of the Written Examination will be decided by the West Bengal Police Recruitment Board. For each incorrect answer, there will be negative marking of ½ of the marks allocated to the question. The marks obtained in the Written Examination will be taken into account while preparing the merit list for selection. The Board will have the discretion to fix qualifying marks in the Written Examination for shortlising candidates for the next stage of selection, i.e. Physical Measurement Test (PMT).

- (b) The recruitment authority, i.e. the West Bengal Police Recruitment Board will preserve the OMR Sheets for not less than 10 (ten) years or till disposal of the Court case, whichever is later.
- **(c) Physical Measurement Test (PMT)** A limited number of candidates will be shortlisted on the basis of marks obtained in the Written Examination for Physical Measurement Test (PMT) which will be of qualifying in nature. The candidates must meet the minimum Physical standards as mentioned below:-

#### (d) Physical Efficiency Test (PET) –

The candidates who have passed the PMT will be called for PET which is also qualifying in nature. The criteria for PET are as follows:-

- (i) The male candidates have to complete 1600 (sixteen hundred) metres run within 06 (six) minutes and 30 (thirty) seconds.
- (ii) The female candidates have to complete 800 (eight hundred) metres run within 04 (four) minutes.
- (iii) The Third Gender candidates have to complete 800 (eight hundred) metres run within 03 (three) minutes and 30 (thirty) seconds.
- (iv) The ex-servicemen above 35 years of age will fulfil the following:-
  - (A) Male candidates have to complete 800 (eight hundred) metres run within 03 (three) minutes and 30 (thirty) seconds; and
  - (B) Female/ Third Gender candidates, if any have to complete 800 (eight hundred) metres run within 04 (four) minutes and 30 (thirty) seconds.
- (v) The candidates considered for appointment under exempted category on compassionate ground with fulfil the following:
  - (A) Male candidates have to complete 1600 (sixteen hundred) metres run within 07 (seven) minutes; and
  - (B) Female or Third Gender candidates have to complete 800 (eight hundred) metres run within 05 (five) minutes.
- **(e) Interview (Maximum Marks-15) :-** All the candidates qualified in physical Efficiency Test (PET) will be called for Interview. The procedure, date time and venue of Interview will be decided by West Bengal Police Recruitment Board. Candidate's ability to speak, read and write Bengali/Nepali language as mentioned in rule 4 will be tested specifically during the interview.

The relevant testimonials of all the candidates called for Interview will be checked and verified at the time of Interview.

- **Reservation** (a) 22% (twenty two percent) posts will be reserved for Scheduled Castes candidates, 6% (six percent) posts will be reserved for Scheduled Tribes candidates, 10% (ten percent) posts will be reserved for Other Backward Classes Category-A candidates, 7% (seven percent (seven Percent posts will be r4eserved for Other Backward Classes Category B candidates and 10% (ten Percent) posts will be reserved for Economically Weaker Sections candidates in terms of extant Government orders.
- (b) 30% (thirty percent) posts will be reserved for exempted category candidates in terms of extant Government orders.
- (c) 15% (fifteen percent) posts will be reserved for Home Guards and National Volunteer Force (NVF) personnel who have completed 03 (three) years of service as on 1<sup>st</sup> day of January of the year of advertisement for recruitment.
- (d) 15% (fifteen percent) posts will be reserved for Civic Volunteers/Village Police Volunteers who have completed who have completed 03 (three) years of service as on 1<sup>st</sup> day of January of the year of advertisement for recruitment.
- (e) 2% (two percent) posts will be reserved for Meritorious Sports Persons.
- (f) The reservation of posts in terms of sub-rule (b), (c), (d) and (e) will be of horizontal nature.

- 7. **Preparation of merit list** The final merit list of provisionally selected candidates shall be prepared on the basis of the total marks obtained by the candidates in the Written Examination and in the Interview. The Board shall publish the list of provisionally selected candidates in its website.
- **8. Verification of Character Antecedents** All provisionally selected candidates shall be required to fill up a Verification Roll which shall be thoroughly enquired into by the concerned authority.

### 9. Medical Examination –

- (a) All provisionally selected candidates will be sent for Medical Examination at the State Government designated hospitals.
- **(b)** The selected candidates should be in good mental and physical health. They should be free from any deformity likely to interfere with their training and efficient performance of their work.
- (c) The candidates shall undergo all necessary medical tests as prescribed by the Department of Health and Family Welfare, Government of West Bengal from time to time.
- (d) Only the candidates declared medically fit will be considered for appointment as Constable in West Bengal Police Force.
- (e) The certificate of medical fitness will be issued by an authorized medical officer.
- **10. Appointing Authority** Assistant Inspector General of Police or Superintendent of Police or Commandant will act as the Appointing Authority for the post of Constable in West Bengal Police.
- **11. Appointment, Training and Probation** (1) The candidates provisionally selected for appointment after successful completion of verification and medical examination, shall be appointed on temporary basis.
- (2) The shall be required to undergo a prescribed course of training in accordance with the Police Regulations, Bengal and/or such rules and regulations as prescribed from time to time.
- (3) All candidates appointed on temporary basis shall be on probation for two years from the date of appointment, after which they may be confirmed in service by the competent authority.
- 12. **Discharge** (a) A Constable may, anytime during the period of probation or while undergoing training, be discharged from service by the competent authority, without proceedings, if found unsuitable for the post.

The order of discharge shall include the grounds of discharge, but no formal proceeding shall be necessary. The order of discharge shall not be given effect to until its confirmation by the next higher authority.

- (b) No appeal shall lie against the order of discharge.
- 13. Saving –Notwithstanding anything contained in these rules, any recruitment process continuing on the date of coming into force of these rules, shall be governed by the rules which exist3ed at the time of advertisement for the said recruitment process.

- (b) The posts of Assistant Sub-Inspector (Motor Transport) are to be filled up as per the rules to be notified for the purpose.
- 3. The expendi5ture in this connection will be met from the appropriate head of account from the budget of West Bengal Police.

#### Rules

- 1. Short title, application and commencement: (1) These rules may be called the West Bengal Police (Recruitment of Assistant Sub-Inspector of Police (Motor Transport) Rules, 2024.
  - (2) They shall come into force on and from the date of their publication in the Official Gazette
- 2. **Definitions** (a) In these rules, unless the context otherwise requires:-
- (i) "Act" means the Police Act, 1861 (5 of 1861);
- (ii) "Department" means the Home and Hill Affairs Department of the State Government;
- (iii) "Board" means Board of Control for Examination and Promotion and Board of Control for Training, both constituted by West Bengal Police Directorate;
- (iv) "State Government" means Government of West Bengal in the Department of Home & Hill Affairs;
- 3. **Method of Recruitment** Recruitment will be made only through promotion from the rank of Police Driver or Grade-I Police Driver in West Bengal Police, based in seniority as per the Gradation List and other stipulated conditions, outlined hereinafter.
- 4. **Eligibility for promotion -** For being considered for promotion to the rank of Assistant Sub-Inspector of Police (Motor Transport), a Police Driver or Grade-I Police Driver will have to render minimum 5 years of satisfactory service and he will have to submit a declaration to the effect that after joining the post of Assistant Sub-Inspector of Police (Motor Transport), he will continue to drive police vehicles.
- 5. **Mode of Selection for Promotion** (1) Selection to the post of Assistant Sub-Inspector of Police (Motor Transport) will be made through (a) Pre-Promotional Training and (b) scrutiny of service records.

- (2) A Police Driver/Grade-I Police Driver will have to qualify Pre-Promotional Training upon completion of which he will be examined on the following subjects: (a) General Knowledge; (b) Test of Driving skills and Traffic-related Rules and/or Regulations; (c) Knowledge regarding Motor mechanics, Equipment Management and repair; (d) Report writing and soft skills; (c) Drill (theoretical) and (f) Drill (practical).
- (3) After, a Police Driver/Grade-I Police Driver qualifies in Pre/Promotional Training, he will be considered for scrutiny to ascertain his (a) length of service and (b) Record of service in observance of the guidelines laid down in this Department G.O. No. 6928/PL/PB/3P-5/92 dated 18.07.1983.

- (4) Other existing criteria in addition to Pre-Promotional Training for awarding promotion in subordinate ranks of West Bengal Police will be strictly adhered to.
- (5) After qualifying in Pre-Promotional Training (Part-I) there will be scrutiny of Service Records (Part-II). The Police Driver/Grade-I Police Driver will be eligible to be considered for promotion only after qualifying both Part-I & Part-II.

Provided that in case of any public emergency of exigency the said promotion from the rank of Police Driver/Grade-I Police Driver to Assistant Sub-Inspector of Police (Motor Transport) can be accorded provisionally without Pre-Promotional Training subject to the condition that the said employee should pass the PPT (Post-Promotional Training) after assuming promotion within a period of 02 (two) years from the date of promotion or before retirement on superannuation whichever is earlier including passing of promotion examination.

#### 6. Promotion Examination :-

## (a) Part-I: The candidates will be examined on the following subject ;-

- (i) General Knowledge: Full Marks: 30 Pass Marks: 12.
- (ii) Test of Driving Skills & Traffic related Rules/Regulation: Full Marks: 60: Pass Marks: 24;
- (iii)Knowledge regarding Motor Mechanics, Equipment Management and repair : Full Marks: 60 Pass Marks : 24
- (iv) Report writing and soft skills: Full Marks: 30, Pass Marks: 12
- (v) Drill (Theoritical): Full Marks: 10, Pass Marks: 04.
- (vi) Drill (Practical): Full Marks: 10, Pass Marks: 04.

## (b) Part-II (Full Marks/Pass Marks)

- (i) Length of Service. 15 \ 30 Qualifying Marks: 12
- (ii)Record of Service 15

Note – While calculating marks of Length-cum-Record of Service (L-C-R-S), the guidelines laid down in G.O. No. 6928-PL/PB-3P-5/82, dated 18.07.1983 will be applicable and the pass marks and length of service will be determined as per G.O. No. 1638-PL/PB/3P-29/04(Part) dated 01.12.2008.

## 7. Preparation of Training Syllabus and Conduct of Training & Examination –

- (a) The Board of Control for Training will prepare the Training Syllabus.
- (b) Swami Vivekananda State Police Academy, Barrackpore, will conduct the Examinations.
- (c) The PPT for promotion from the rank of Police Driver/Grade-I Police Driver to Assistant Sub-Inspector of Police (Motor Transport) will be minimum six weeks of duration.
- (d) A Police Driver/Grade-I Police Driver will be given a maximum of four chances to clear the PPT examinations.
- (e) The Officers shall be confirmed in higher rank and their inter-se seniority will be fixed only after successful completion of PPT including Promotion examination within the stipulated period of 02 (two) years from the date of provisional promotion.
- (f) In case PPT Promotion examination is not completed successfully within 02 (two) years or before retirement on superannuation, such Officers shall be automatically reverted back to their lower rank unless allowed specifically by the Government.
- (g) The promotion to the rank of Assistant Sub-Inspector of Police (Motor Transport) will be given depending on the availability of vacancies in the said rank. However, the final decision to allot any

- Police Driver/Grade-I Police Driver to the rank of Assistant Sub-Inspector of Police (Motor Transport) shall be with the Board of Control of Examination and Promotion of West Bengal Police.
- (h) The Superintendent of Police will be appointing authority for the post of Assistant Sub-Inspector of Police (Motor Transport)
- **8.** Confirmation and Seniority on Promotion A Police Driver/Grade-I Police Driver upon his promotion to the rank of Assistant Sub-Inspector of Police (Motor Transport), shall be confirmed in the higher rank and his inter-se seniority will be fixed only after successful completion of PPT (Post Promotional Training) including Promotion examination within the stipulated period of 02 (two) years from the date of provisional promotion.
- **Saving** Notwithstanding anything contained in these rules, any recruitment process continuing on the date of coming into force of these rules, shall be governed by the rules which existed at the time of the said recruitment process.
- 10. Interpretation If any difficulty arises in respect of interpretation of any term phrase used in these rules, the matter shall be referred to the State Government and the decision of the State Government in this regard shall be final and binding.

Following points were submitted for the discussion and decision there upon by the Board:

## 1. Approval of the final result of detained Recruit Constables of Batch No. 224/2023-2024.

> The result sheet of final examination of 15 detained Recruit Constables of Batch No. 224/2023-2024 was placed before the members of the Board. 15 detained RCs appeared in the Supplementary Examination and have completely passed in all indoor and outdoor subjects. Board unanimously approved the result.

# 2. Revision of syllabus of Cadet SIs (UB) batch no. 69/2023-24 and Cadet SIs (AB) batch No. 40/2023-24 (New Batch) in view of notification of New Criminal Laws.

In view of the notification of New Criminal Laws which are to come into effect from 1<sup>st</sup> July, 2024, IGP SVSPA proposed that the corresponding syllabus of criminal major acts for ongoing training of Cadet SIs may be revised by replacing the corresponding provisions of 3 New Criminal Laws i.e. Bharatiya Nyaya Sanhita, 2023, Bharatiya Nagarik Suraksha Sanhita, 2023 and Bharatiya Sakshya Adhiniyam 2023. Board members deliberated upon the same and it was decided that, henceforth, further training of cadet SIs (new batch) may be conducted as per new criminal laws and IGP SVSPA will put up revised syllabus for approval of BoC in the next meeting.

- 3. Modular course for Cadet SIs (UB) batch No. 68/2023-24 and Cadet SIs (AB) batch No. 39/2023-24 (Old Batch) in view of notification of New Criminal Laws.
- > IGP, SVSPA, informed that basic training of old cadet batch has been nearly completed. 02 weeks Modular Course on the New Criminal Laws has been drafted for the old batch of Cadet SIs (UB) and (AB) for familiarization of New Criminal Laws. The modular course will be conducted after the final examination and training period extended to that extent. The draft has been placed before the Board members and the Board unanimously approved the same. Board also directed that one class per day can be organized for orientation of new criminal laws before examination.
- 4. Revision of syllabus of Dy. SP (U/T) of batch No. 71/2023-24 in view of notification of New Criminal Laws.
- ➤ Revision of syllabus of Dy. SP (U/T) was also discussed along the lines of discussion for Cadet SIs (new batch). Board members decided that, henceforth, further training of Dy. SP (U/T) may be conducted as per new criminal laws and IGP SVSPA will put up revised syllabus for approval of BoC in the next meeting.

### 5. Miscellaneous:

- ➢ BoC also resolved that training of new RCs (including those of Kolkata Police) should henceforth be conducted as per new criminal laws. Further, an orientation programme of 07 days may be conducted for RCs currently undergoing training at STC Barjora and TTC SAP 7<sup>th</sup> Bn.
- ➤ In Miscellaneous agenda, a point raised to the effect that, external paper setters are often not complying with the orders from Police Directorate and are returning the letters regarding setting u p of question papers which makes it impossible for the SVSPA examination cell to conduct the examinations as per schedule. Board decided that PD may be requested to make setting up of question papers mandatory for senior officers whose names have been approved by PD. Board also asked IGP SVSPA to keep one paper setter in reserve category for each question paper.
