No. 1637(2)-PL/PB/14M-37/2020 dated 16.09.2020, and the eligibility for granting such benefit in favour of a Civic Volunteer/Village Police Volunteer has been stated in this Department G.O. - ➤ The Range Board for promotion of eligible 39 (thirty nine) Wireless Operators of the year 2006 was held on 29/07/2024 at Telecom(HQ), WB, for promotion to the rank of Supervisor (Operational) Grade-II, of Telecom (HQ), WB. Out of 39 (thirty nine) Wireless Operators 36 (thirty six) Wireless Operators were declared provisionally "fit" and 03 (three) Wireless Operators were declared "Unfit" for promotion to the next higher rank.

Following points were submitted for the discussion and decision there upon by the Board:

1. Approval of the Final result of Dy. SP(U/T) Batch No. 71/2023-24.

The result sheet of Final Examination of Dy. SP (Prob) Batch No. 71/2023-24 was placed before the members of BoC. 21 probationers appeared in the examination and all of them have qualified in all subjects and have been released from SVSPA for CIF attachment. The members of the board unanimously approved the same.

## 2. Revision of syllabus of Cadet SIs (UB & AB), Junior Recruit Constbales and Recruit Constable of Excise Deptt.

#### A] Syllabus of Cadet SIs (UB & AB)

As per decision of BoC meeting dated 15.07.2024 and considering the changes in three major laws, the revised draft syllabus of Cadet SIs (UB & AB) was placed before the Board. The chapters and sections of three major laws have been incorporated replacing the old laws i.e. IPC, Cr. PC & IEA. This apart, some minor changes as per new criminal laws and some special Acts have been incorporated in Paper-I (Law and Procedure). Minor changes have also been made at certain other places which were pointed out to the Board by SVSPA. The Board approved the revised syllabus.

#### B] Syllabus of Junior Recruit Constables

The members of the board have opined that a major change is required in the syllabus of Junior Recruit Constables, considering their day to day duties which are more or less similar with Constables. Therefore, the members of the board have decided that the syllabus be thoroughly revised and to be placed before the members of BoC in next meeting for approval.

However, the final examination of the current batch of Junior Recruit Constables which has been undergoing training at SAP 7<sup>th</sup> Bn. will be held as per of new criminal laws.

#### C] Syllabus of Recruit Constables of Excise Deptt.

The existing syllabus of Recruit Constable of Excise Deptt. has been revised in the light of three new criminal major laws was put up before the Board. The basic concept of Bharatiya Sakshya Adhiniyam and a new topic i.e. Soft Skills has been included in the syllabus. The Board approved the same.

#### 3) Miscellaneous:

In view of the upcoming examination of the large number Cadet SIs (UB & AB) and the guidelines in syllabus under the caption "Evaluation of Training, internal assessment and final examination", Board authorized IG SVSPA to get all the indoor and outdoor (written examination) subject answer papers evaluated by the faculties of SVSPA and or the competent retired police officers based on the model answers.
