**MINUTES OF THE MEETING OF THE BOARD OF CONTROL FOR EXAMINATION AND PROMOTION HELD ON 16.10.2025**

A meeting of the Board of Control for Examination and Promotion was held on 16/10/2025 at 16:30 hrs. in the DGP'S Conference Hall, at Bhabani Bhaban, Kolkata-27.

Shri Vineet Kumar Goyal, IPS, Additional Director General & Inspector General of Police (Administration), West Bengal, Chairman of the Board presided over the meeting.

The following members of the Board attended the meeting:-

1. Shri Rishikesh Meena, IPS, Inspector General of Police, Organisation, West Bengal.
2. Smt. Krishnakali Lahiri, IPS, Deputy Inspector General of Police (Planning & Welfare), West Bengal.
3. Shri Arindam Dutta Chowdhury, IPS, Deputy Inspector General of Police (Administration), West Bengal.
4. Shri Amit Kumar Singh, IPS, Vice Principal, SVSPA, Barrackpore in the rank of DIG. -Co-opted Member.
5. Shri Dipanjan De, Sr. Deputy Secretary to the Govt. of West Bengal, Home and Hill Affairs Department.

The following points were discussed in the meeting of BOC for Examination & Promotion.

1. **To examine the 'Length-Cum-Record of Service Part-III' of ASI(UB)/124 Tarak Nath Adhikary of Siliguri PC for Promotion to the Rank of Sub-Inspector of Police (Unarmed Branch) as the decision in r/o the said police personnel had been "kept in abeyance" by BOC(E&P) held on 25/08/2025 and 26/08/2025 in view of reviewing the Final Order passed by the disciplinary authority vide Siliguri PC CO No. 900 dated 06/03/2025 in c/w Siliguri PC Proceeding No. 07/2025 dated 20/02/2025.**

- The Range Board held by CP Siliguri PC on 27/05/2025 and communicated under his Memo No. 951/RO dated 27/05/2025 declared ASI(UB)/124 Tarak Nath Adhikary of Siliguri PC 'Unfit' for promotion to the rank of SI(UB) as the incumbent was under currency of punishment awarded in Siliguri PC Proceeding No. 7/25 dated 20/02/2025. The name of the incumbent was mentioned in Range Board sl. no. 05. The incumbent, however, secured qualifying marks in L.C.R.S. The BOC(E&P) held on 25/08/2025 and 26/08/2025 found that the punishment period awarded to the incumbent was completed. During scrutiny the BOC(E&P) observed that the punishment was awarded to the delinquent was not in accordance with the provisions laid down under rule 45 of WBSR Part-I. The Members of the BOC(E&P) held on 25/08/2025 and 26/08/2025 unanimously decided to ask CP Siliguri PC to review the punishment awarded by the disciplinary authority and to pass his revisionary order as per rule 884 of PRB, and in the meantime, the promotion of ASI(UB)/124 Tarak Nath Adhikary of Siliguri PC is 'kept abeyance'. CP Siliguri PC, the revisionary authority, passed his revisionary order by reducing one increment of the charged officer ASI(UB)/124 Tarak Nath Adhikary of Siliguri PC for six months w.e.f. 01/09/2025 to 28/02/2026 without cumulative effect vide CO No. 2961 dated 01/09/2025 of Siliguri PC. The same was communicated under Memo No. 1677/RO, SPC dated 01/09/2025 of CP, Siliguri PC.
- The matter is placed before the BOC (E&P) for perusal and decision.

**DECISION:** The members of the BOC(E&P) perused the matter and unanimously decided and declared ASI(UB)/124 Tarak Nath Adhikary of Siliguri PC "Unfit" for promotion as the incumbent is under Currency of Punishment.

The sealed L.C.R.S sheets which was examined by the BOC (E&P) on 25/08/2025 and 26/08/2025 is reopened and necessary noting has been incorporated in respect of ASI(UB)/124 Tarak Nath Adhikary in view of the

present development which has been signed by all members present in the BOC (E&P) including the Chairman.

**2. To open and examine the sealed cover in r/o ASI(UB)/154 Shimul Mondal of Bidhannagar PC for promotion to the rank of SI(UB).**

- The promotion of ASI(UB)/154 Shimul Mondal (WBP ID: 2007009508) of Bidhannagar PC to the rank of SI(UB) was kept in “**Closed Cover**” by the BOC(E&P) held on 25/08/2025 and 26/08/2025, in view of the pendency of departmental proceedings.
- Jt. CP(HQ) Bidhannagar PC vide Org No. 1511/RO, BDN PC dated 11/09/2025 has intimated that the departmental proceeding vide Bidhannagar PC proceeding No. 14/24 dated 20/11/2024 which was pending against ASI(UB)/154 Shimul Mondal of Bidhannagar PC has been disposed of by exonerating ASI(UB)/154 Shimul Mondal of Bidhannagar PC from the charges levelled against him and the instant proceeding is **filed** vide CO No. 3177/CP BDN PC dated 09/09/2025.
- The matter is placed before the BOC (E&P) for its consideration.

**DECISION:** The Members of the BOC (E&P) perused and examined the relevant documents and observed that the name of ASI(UB)/154 Shimul Mondal of Bidhannagar PC was kept in ‘**Closed Cover**’ by the BOC(E&P) held on 25/08/2025 and 26/08/2025, in view of the pendency of departmental proceedings against him. Whereas, ASI(UB)/153 Sanjib Kumar Banerjee of Bankura being the immediate junior to ASI(UB)/154 Shimul Mondal of Bidhannagar PC was ordered for promotion to the rank of SI(UB) vide order dated 22/09/2025 conveyed under Memo No. 594(168)-CRO//CRO-05/2025 dated 22/09/2025 of DIG(A), WB.

The Members of the BOC(E&P) opened and examined the “Closed Cover” in respect of ASI(UB)/154 Shimul Mondal of Bidhannagar PC and found him “**Fit**” for promotion to the rank of SI(UB) as the instant departmental proceeding initiated against him has since been filed, exonerating him from all charges levelled against him.

Now, the members of BOC(E&P) unanimously decided to accord promotion of ASI(UB)/154 Shimul Mondal of Bidhannagar PC to the rank of SI(UB) with seniority in accordance with his immediate junior ASI(UB)/153 Sanjib Kumar Banerjee of Bankura. ASI(UB)/154 Shimul Mondal will be entitled to get all consequential service benefits notionally with effect from 22/09/2025. However, he will get actual benefits from the date he assumes the charge as SI(UB).

The “Closed Cover” is accordingly disposed of.

**3. To examine Result of the Final Examination of Pre-Promotional Training Course of SI(UB) for promotion to the rank of Inspector of Police (UB) of Batch No. 36/2025.**

- IGP, SVSPA, WB, Barrackpore has sent memo no. File No.SVSPA/Exam Sec/SI(UB)/01(XIV)/2018-3017 dated 09/09/2025, containing the Result of the Final Examination of Pre-Promotional Training Course of SI(UB) for promotion to the rank of Inspector of Police (UB) of Batch No. 36/2025 which commenced on and from 28/07/2025 and ended on 26/08/2025 vide Police West Bengal Org No. 229/CRO//PER/A-10/2023 dated 23/07/2025.
- Total 43(forty three) SIs(UB) reported at SVSPA, WB, Barrackpore to undergo the aforesaid training. They completed the training and appeared in the final examination in all subjects and qualified successfully.
- The result of the same is placed before the ‘Board of control for Examination and Promotion’ for perusal and approval.

**DECISION:** The Board examined the result and approved the same for next course of action.

Total 43(forty three) trainees have been qualified in the Final Examination of Pre Promotional Training Course for Promotion to the rank of Inspector of Police (UB).

**4. To examine Result of the Final Examination of Post-Promotional Training Course of SI(AB) for confirmation to the rank of Inspector of Police (AB) of Batch No. 17/2025 and Supplementary examination of Pre-Promotional Training Course of SI(AB) of Batch No. 16/2025.**

- IGP, SVSPA, WB, Barrackpore has sent memo no. SVSPA/Exam.Cell/PPT/SI(AB)/02(VII)/2018-3016 dated 09/09/2025, containing the Result of the Final Examination of Post-Promotional Training Course of SI(AB) for confirmation to the rank of Inspector of Police (AB) of Batch No. 17/2025 and Supplementary examination of Pre-Promotional Training Course of SI(AB) of Batch No. 16/2025 which commenced on and from 28/07/2025 and ended on 26/08/2025 vide Police West Bengal Org No. 229/CRO//PER/A-10/2023 dated 23/07/2025 and Police West Bengal Org No. 70/CRO//PER/A-10/2023 dated 11/03/2025.
- 01(one) Inspector of Police (AB) reported at SVSPA, WB, Barrackpore to undergo the aforesaid training. He has completed the training and appeared in the final examination in all subjects and qualified successfully.
- On the other hand 01(one) SI(AB) out of 02(two) SIs(AB) of different district / Battalions who were not qualified in Paper-I & Paper-II of Indoor subject in the Final Examination of PPT Batch No. 16/2025 also appeared in the Supplementary examination and qualified successfully.
- The result of the same is placed before the 'Board of control for Examination and Promotion' for perusal and approval.

**DECISION:** The Board examined the result and approved the same for next course of action.

01(one) Inspector of Police (AB) has been qualified in the Final Examination of Post-Promotional Training Course for confirmation to the rank of Inspector of Police (AB) of Batch No. 17/2025.

01(one) SI(AB) out of 02(two) SIs(AB) of different district / Battalions who were not qualified in Paper-I & Paper-II of Indoor subject in the Final Examination of PPT Batch No. 16/2025 also appeared in the Supplementary examination and qualified successfully.

**5. To examine Result of the Final Examination of Post-Promotional Training Course for confirmation to the rank of ASI(MT) of Batch No. 04/2025 and Supplementary examination of PPT Course of ASI(MT) of Batch No. 03/2025.**

- IGP, SVSPA, WB, Barrackpore has sent memo no. SVSPA/Exam.Cell/PPT/ASI(MT)/07(IV)/2025-3100 dated 18/09/2025, containing the Result of the Final Examination of Post-Promotional Training Course for confirmation to the rank of ASI(MT) of Batch No. 04/2025 and Supplementary examination of PPT Course of ASI(MT) of Batch No. 03/2025 which commenced on and from 28/07/2025 and ended on 06/09/2025 vide Police West Bengal Org No. 224/CRO//CRO-07/2025 dated 22/07/2025.
- Total 76(seventy six) out of 80 candidates reported at SVSPA, WB, Barrackpore to undergo the aforesaid training course. Out of them 02(two) candidates returned to their respective unit on medical ground. Remaining 74(seventy four) candidates appeared in the final examination and qualified successfully.
- On the other hand 01(one) ASI(MT) of IB, WB who were detained due to remaining absent for more than 15% of his training days at PPT Batch No. 03/2025 also appeared in the Supplementary examination and qualified successfully.

➤ The result of the same is placed before the 'Board of control for Examination and Promotion' for perusal and approval.

**DECISION:** The Board examined the result and approved the same for next course of action.

Total 74(seventy four) trainees have been qualified in the Final Examination of Post-Promotional Training Course for confirmation to the rank of ASI(MT).

ASI(MT)-93 Ajoy Kumar Singh (result sheet sl. no. 01) of ADPC and ASI(MT)-1281 Pintu Paul (result sheet sl. no. 69) of Sealdah GRP both of PPT Batch No. 04/2025 returned to their respective unit on medical ground.

CP, ADPC and SRP Sealdah GRP will ensure that, ASI(MT)-93 Ajoy Kumar Singh (result sheet sl. no. 01) of ADPC and ASI(MT)-1281 Pintu Paul (result sheet sl. no. 69) of Sealdah GRP who did not complete the PPT, should undergo the PPT in the next Batch.

01(one) ASI(MT) of IB, WB who were detained due to remaining absent for more than 15% of his training days at PPT Batch No. 03/2025 also appeared in the Supplementary examination and qualified successfully.

**6. To examine Length-Cum-Record of Service of 35(thirty five) Wireless Operators for promotion to the rank of Supervisor (Operational) Grade-II in West Bengal Police Telecommunication Branch.**

➤ DIG, Telecommunication, WB in the rank of IGP vide his Memo No. 2525/RO dated 19.09.2025 has sent a letter enclosing the Minutes of the meeting of WBP Telecommunication Range Board held on 19.09.2025 and Broad Sheet containing 34 (thirty four) willing Wireless Operators for promotion to the rank of Supervisor (Operational) Grade-II in West Bengal Police Telecommunication Branch and 01(one) candidate is found 'unwilling' for promotion.

➤ The Range Board declared that 30(thirty) Wireless Operators are 'Fit' and 02(two) Wireless Operators are 'Provisionally Fit' for promotion to the next higher rank and 02(two) Wireless Operators are 'Unfit' for promotion.

➤ At present, there are 07(seven) vacancies in the rank of Supervisor (Operational) Grade-II in West Bengal Police Telecommunication Branch. It has also been stated that, according to 50-Point Roster of Supervisor(Operational) Grade-II the last vacancy i.e. 23<sup>rd</sup> point was filled up during the last round of Promotion order issued and the vacancy will be filled up from the 24<sup>th</sup> Point of 50-Point Roster of Supervisor(Operational) Grade-II.

➤ The L-C-R-S sheet has been placed before the 'Board of control for Examination and Promotion' for perusal and approval.

**DECISION:** The Board examined and approved the L-C-R-S of 34(thirty four) willing Wireless Operators and 01(one) unwilling Wireless Operator for promotion to their next higher rank received under Memo No. 2525/RO dated 19.09.2025 of DIG, Telecommunication, West Bengal in the rank of IGP.

The Range Board declared that 30(thirty) Wireless Operators are '**Fit**', 02(two) Wireless Operators are '**Provisionally Fit**' for promotion to their next higher rank and 02 candidates are '**Unfit**' for promotion. W opr. Ananta Mondal (Broad Sheet Sl. No. 01) failed in L-C-R-S while W opr. Sandipan Biswas (Broad Sheet Sl. No. 24) declared 'Unfit' due to pendency of criminal proceedings against him.

Hence, promotion of W opr. Sandipan Biswas (Broad Sheet Sl. No. 24) may be kept in '**Closed Cover**' till disposal of criminal proceedings pending against him, subject to filling up of vacancies in the rank of

Supervisor(Operational) Grade-II considering his seniority and comes within the zone of consideration for promotion as per the requirement of 50-point roster.

The promotion of Wireless Operator to the rank of Supervisor(Operational) Grade-II may be accorded observing all formalities, maintaining the inter-se-seniority of the candidates as per West Bengal Services (Determination of Seniority) Rules, 1981 and existing rules of 50-Point Roster amongst the 'fit' candidates as per available vacancy for the post of Supervisor (Operational) Grade-II.

The Competent Authority of Telecommunication, West Bengal shall accord promotion of Wireless Operator to Supervisor (Operational) Grade-II subject to availability of vacancy and in accordance with existing rules and procedures.

**7. To examine the prayer submitted by SI(UB) Biplab Kumar Das of Darjeeling regarding rectification of promotional benefit retrospectively and seniority to the rank of SI(UB).**

- **SP Darjeeling**, vide his Memo No. 965/RO dated 05/06/2025, has forwarded a prayer dated 11/04/2025 of SI(UB) Biplab Kumar Das of Darjeeling. In his prayer **SI(UB) Biplab Kumar Das** of Darjeeling has stated that during his incumbency at **Dakshin Dinajpur as ASI(UB)**, he was promoted to the rank of SI(UB) and was posted to **Malda** vide Memo No. 507(168)/PER/A//PER/A-88/2021 dated 26/07/2021 of West Bengal Police Directorate. Accordingly, he proceeded to join Malda District to assume his superior charge as SI(UB). But, due to non-availability of vacancy at Malda District, he was not allowed to assume his superior charge at Malda District and he was returned to Dakshin Dinajpur District. Later, he was posted to Malda district vide Memo No. **416(24)/PER/A//PER/A-04/2021** dated **08/09/2022, on promotion as SI(UB)**. Accordingly, he **joined Malda on promotion as SI(UB) on 10/09/2022**.
- Now, he has prayed for getting his promotional benefits and seniority retrospectively from the date when he proceeded to join Malda District on 02/08/2021 to assume his superior charge as SI(UB), but he was not allowed to join there due to non-availability of vacancy.
- The matter is placed before the 'Board of control for Examination and Promotion' for decision.

**DECISION:** The Board examined the relevant documents and found that SI(UB) Biplab Kumar Das of Darjeeling, during his incumbency at Dakhin Dinajpur as ASI(UB), in compliance with the Memo No. 507(168)/PER/A//PER/A-88/2021 dated 26/07/2021, had reported in Malda district on 02/08/2021 to assume his superior charge as SI(UB) on promotion. But, due to the non-availability of vacancy in the rank of SI (UB), he was not allowed to join there.

Subsequently, the Officer was posted on deputation to Malda District on promotion as SI(UB) from Dakshin Dinajpur District vide Memo No. 758(18)/PER/A//PER/A-69/2019 dated 28/09/2021.

Thereafter, ASI(UB)-552 Biplab Kumar Das of Dakshin Dinajpur District was posted to Malda District on promotion as SI(UB) vide Memo No. **416(24)/PER/A//PER/A-04/2021** dated **08/09/2022 of West Bengal Police Directorate and the incumbent assumed his charge as SI(UB) at Malda District on 10/09/2022**.

In view of the above circumstances, the Members of the BOC (E&P) decided to call for a detailed fact-finding report from the Superintendent of Police, Malda and Superintendent of Police, Dakshin Dinajpur through IGP, Malda Range. Upon receipt of the said report on the above matter shall be placed before the next BOC (E&P).

**8. Promotion matter of ASI(UB)/153 Sanjib Kumar Banerjee of Bankura for promotion to the rank of SI(UB).**

➤ SP Bankura, vide his Org No. 2087/RO dated 25/09/2025 has informed that ASI(UB)/153 Sanjib Kumar Banerjee of Bankura is posted to Jhargram on promotion to the rank of SI(UB) vide Memo No. 594(168)/CRO//CRO-05/2025 dated 22/09/2025 but a departmental proceeding has been initiated against him vide Bankura District Proceeding No. 18/25 dated 13/09/2025 and DO No. 3491 dated 13/09/2025.

➤ The matter is placed before the BOC (E&P) for decision.

**DECISION:** After perusal of records it is seen that ASI(UB)/153 Sanjib Kumar Banerjee of Bankura was provisionally promoted to the rank of SI(UB) and posted to Jhargram vide Memo No. 594(168)/CRO//CRO-05/2025 dated 22/09/2025. His name is in sl. no. 88 of the said provisional promotion-cum-transfer order. He was accorded provisional promotion to the next higher rank as he was found "fit" on that point of time subject to the condition that no departmental proceeding, criminal case, or proceeding before the Vigilance Commission is pending against him, and that he is not under any currency of punishment.

However, the Board unanimously decided that, since a departmental proceeding is pending against ASI(UB)/153 Sanjib Kumar Banerjee of Bankura before assuming of superior charge, the promotion-cum-transfer order dated 22/09/2025 in respect of ASI(UB)/153 Sanjib Kumar Banerjee of Bankura vide Memo No. 594(168)/CRO//CRO-05/2025 dated 22/09/2025 stands '**Cancelled**' in his case.

The promotional vacancy in respect of ASI(UB)/153 Sanjib Kumar Banerjee of Bankura is kept in "**Closed Cover**" procedure in view of the pending departmental proceeding against him vide Bankura District Proceeding No. 18/25 dated 13/09/2025 and D.O. No. 3491 dated 13/09/2025.

The sealed L.C.R.S sheets which was examined by the BOC (E&P) on 25/08/2025 and 26/08/2025 is reopened and necessary noting has been incorporated in respect of ASI(UB)/153 Sanjib Kumar Banerjee in view of this recent development which has been signed by all members present in the BOC (E&P) including the Chairman.

SP, Bankura is directed not to release him to assume his Superior Charge to the rank of SI(UB). The matter should be incorporated in the service book of ASI(UB)/153 Sanjib Kumar Banerjee.

**Police Order No.13**

**Dated.10.11.2025**

**Sub: Best Kept Police Station, Best Kept District, Best Kept Commissionerate, Best Kept Battalion and Best Kept Other Units in West Bengal Police.**

1. With a view to provide competitiveness in performance and to improve the physical appearance of the Police Stations and the offices of the Superintendents of Police including the lands attached to them, a system for selection of Best Kept Police Stations and Districts of West Bengal Police is in place for quite some time.
2. It has now been decided to review the system and make it more inclusive giving level playing field to various units and include Armed Police Battalions into its ambit.
3. Henceforth Best Kept Police Station will be decided for 03(three) categories of Police stations of Districts/Commissionerates for fair assessment of performance:-
  - a) Inspector-in-Charge Police Station.
  - b) Officer in Charge (SI) Police Station.
  - c) Women Police Station.
4. **Considering the nature and work of GRPS there will be a separate category of Best Kept PS for the GRPS. However GRP districts will continue under the same category for Best Kept District.**
5. **Since Cyber PS across the state plays crucial role in prevention, detection and investigation of cyber related offences, in order to healthy competition and to improve further efficiency there will be a separate category of Best Kept Cyber PS among District/Commissionerate.**
6. To improve the functioning and bring elements of competitiveness, assessment of performance of various Armed Police Battalions under West Bengal Policeis also required. For this, Best Kept Battalion under the Armed Police will be selected.
7. Since the police station records and statistics are maintained as per the calendar year, the selection of Best Kept Police Stations and Districts shall be based on assessment of their upkeep and performance during the relevant calendar year. Apart from the upkeep and maintenance of the police station buildings and various offices under the Commissioner/ Superintendent of Police the following factors shall be taken into account in selecting Best Kept Units :-
  - a) Discipline of the officers and men and the quality of manpower management.
  - b) In-service training imparted to the police personnel.
  - c) State of various records and registers maintained at the P.S. and the Superintendent's/ Commissioner's Office.
  - d) Use of information technology in maintenance of police station and office records.
  - e) Prevention and detection of crime, maintenance of law & order during the year.
  - f) Quality of response to public grievances, timely completion of passport verification, C&A verification etc.
  - g) Image of the police station and district/city police as assessed by interaction with public in general and other stake holders.
  - h) Steps taken towards the welfare of police personnel/participation in sports and other recreational activities.
  - i) Status of functioning of computers, CCTV system, emergency response system, vehicles, fire fighting and other equipments.
  - j) Quality of financial management by the district police office.
  - k) Quality of supervision of investigation and inspection by the senior police officers.

8. All Superintendents shall submit their recommendations to the Range Deputy/Inspectors General for the Best Kept PS of their districts for the preceding year by the end of February every year. The DIG / IG in turn shall select one of the police station of their range from among the recommended police station by conducting a thorough inspection themselves and send a report as per prescribed format (**Annexure-I**) to respective Zonal IG / ADG by 31<sup>st</sup> March. Zonal IG / ADG will select one from among the PSs selected by the range DIG / IG and forward the recommendation to DG & IGP, WB by 30<sup>th</sup> April. In case of Cyber PS, all District SPs/CPs shall submit their nominations for the Best Kept Cyber PS of their District/Commissionerate (**Annexure-V**) to DG/ADG Cyber Cell, WB by 31<sup>st</sup> March who in turn will select not more than two Cyber PSs among the nominated Cyber PSs and forward the recommendation to DG & IGP, WB by 30<sup>th</sup> April.
9. In case of Police Commissionerates the recommendations for the Best Kept PS shall be made by the Commissioners of Police (**Annexure-I**) to the ADG (L&O) by 31<sup>st</sup> March and the ADG (L&O) shall send his recommendation for not more than two Police Stations from the Police Commissionerates to DG & IGP, WB by 30<sup>th</sup> April positively. In case of GRPS all SRPs shall submit their nomination to DG/ADG Railways by 31<sup>st</sup> March as per prescribed proforma (**Annexure-II**) who in turn shall send his recommendation for not more than two GRPS from among the nominated GRPS and forward the recommendation to DG & IGP, WB by 30<sup>th</sup> April.
10. A similar procedure shall be adopted for the selection of the Best Kept District. In this case the process of nomination shall be initiated by the range DIG / IG by conducting a thorough inspection of the District. Respective Zonal IG / ADG after receiving nomination for the Best Kept District shall conduct through inspection and send a report filled up in the prescribed format (**Annexure-III**) to DG & IGP, WB by 30<sup>th</sup> April positively. In case of Commissionerate the recommendation for the Best Kept Commissionerate shall be made by ADG (Law & Order) from among the Commissionerates by 30<sup>th</sup> April.
11. The recommendation for the Best Kept Armed Battalion under West Bengal Police shall be made based on the Annual inspection of the Battalion conducted by the respective DIG / IG (Armed Police) of Brigades. They will submit their report to ADG / DG, AP by 30<sup>th</sup> March who in turn will send the nomination Brigade wise (DIG, AP Barrackpore/DIG, AP North Bengal/DIG, AP, EFR Bn./DIG, AP Durgapur) to DG & IGP, WB by 30<sup>th</sup> April in the prescribed filled up format (**Annexure-IV**).
12. The final selection shall be made by a Committee appointed for the purpose by the DGP and the committee shall submit the recommendation for the Best Kept PS, the Best Kept GRPS, the Best Kept Cyber PS, the Best Kept District, the Best Kept Police Commissionerate and Best Kept Battalion within a period of two months. The committee shall also recommend second best units in all categories.
13. The committee members as appointed may include additional points for evaluation of performance of the units. The Annexures attached are indicative and not inclusive.
14. The trophy for the Best Kept PS in the State, the Best Kept District, the Best Kept GRPS, the Best Kept Cyber PS, the Best Kept Police Commissionerate and Best Kept Battalion will be awarded by the DGP every year. The personnel posted at the Best Kept PS of the State during the period under consideration may be additionally rewarded by the DGP. Every Superintendent/Commissioner of Police/Commandant may separately award a trophy or suitably reward the personnel of the Police station/Battalion adjudged best in his/her District/ Commissionerate/Battalion.
15. The Best Kept Police Station, Best Kept Cyber Police Station, Best Kept Govt. Railway Police Station, Best Kept District, Best Kept Commissionerate and Best Kept Battalion adjudged by the final Selection Committee will not be participated for 02(two) consecutive years.
16. This order is issued in supersession of Memo No.1425(38)/ORG-129/03 dated 09.07.2003 and will take effect from 01.01.2023.

The Cyber Crime Wing, West Bengal was established vide Notification No. 247-PL Dated: 06.02.2024 & 2791-PL dated 17.10.2023 of Home & Hill Affairs Department. Presently, the Child Protection Unit (CPU) of Cyber Crime Wing, West Bengal is functioning as the nodal unit for monitoring and handling complaints related to Child Sexual Exploitive and Abuse Materials (CSEAM) and National Centre for Missing & Exploited Children (NCMEC) Cyber Tipline.

Now, it has been decided that all complaints related to the following categories shall be handled by a newly established unit titled “Women & Child Protection Cell (WCPC)”, which will function under the direct control and supervision of the Cyber Crime Wing, West Bengal :

1. CP/RGR (Child Pornography/Rape, Gang Rape)
2. Sexually explicit contents
3. Sexually obscene materials
4. CSEAM (Child Sexual Exploitive and Abuse Materials)
5. NCMEC (National Centre for Missing & Exploited Children)

**Police Order No. 15 of 2025**

**Dtd. 4<sup>th</sup> December, 2025**

**Sub. :** Investigation of cyber crime cases by West Bengal cyber Crime Wing (WB-CCW) under West Bengal Police.

Whereas, the complaints related to cybercrime are presently being dealt with by different police stations including the existing 34 (thirty four) Cyber Crime police stations under different Commissionerates/Districts, and by one Cyber Crime Police Station under the Criminal Investigation Department, West Bengal.

And whereas, in order to ensure administrative convenience and better management of cybercrime-related matters, the Home & Hill Affairs Department, Government of West Bengal, vide Notification No. 2791-PL/PB/14M-04/15 dated 17.10.2023, constituted the West Bengal Cyber Crime Wing (WB-CCW) under West Bengal Police.

And whereas, pursuant to the aforesaid notification, the Cyber Crime Wing, West Bengal is presently monitoring and supervising several cybercrime cases across the 34 Cyber Crime Police Stations in different districts of West Bengal.

And whereas, the Investigating Officers in the districts are simultaneously engaged in Law-and-order duties and other administrative responsibilities, resulting in delays in taking timely and prompt action in cybercrime cases, where any lapse or delay may enable the violators to evade detection etc;

And whereas it has been considered necessary that, for better supervision, effective monitoring, and ensuring prompt and specialized action in cybercrime cases, the guidance, technical expertise and specialized knowledge of the Officers of the Cyber Crime Wing (WB-CCW) should be utilized to facilitate the Investigating Officers;

And whereas, cybercrimes are strongly interlinked to perpetrators, mule accounts, SIMs, bank branches, account opening personnel, cloud service providers, crypto wallets, and others, a silo-based investigation model that worked well for traditional crime may not be sufficient in the case of cyber-crimes thus recognizing the need to develop a mechanism for the cooperative investigation of cybercrimes so that efforts can be better coordinated to address the extensive interconnections visible in cyber crime data on a module basis.

Now, therefore, to effectively deal with cybercrime, the Head of the Cyber Crime Wing (WB-CCW) is empowered to take the following measures:

(a) associate with investigation to effect arrest, search and seizure, or to advise or assist in investigation without assuming control, of any major cybercrime case, as may be required for the effective and expeditious investigation of Cyber Crime cases,

(b) assume control of the investigation and/or, establish Special Investigative Teams as and when necessary, by including officers from different Districts, Police Commissionerates, and CCW itself for the investigation of a module with the approval of DG & IGP.
