Cell, HR/O/3P-12/2025 dated 08.11.2025 of Home & Hill Affairs Department, Police Service Cell, Government of West Bengal and vide Memo. No. 622/1-Pers-I/Pers-I-150/2025 dated 10.11.2025 of Deputy Inspector General of Police (Personnel), West Bengal to the post of Deputy Superintendent of Police (on probation) in West Bengal Police under the category of medal-winning sports person under special dispensation in terms of Notification No. 629-PL dated 07.03.2024 of the Home & Hill Affairs Department, Government of West Bengal, in the Pay Matrix Level-16 (Rs. 56,100/- to Rs. 1,44,330/-) plus allowances, as admissible from time to time.

Police Order No 16 of 2025

Dated: 11/12/2025

Sub: Formation of State Disaster Response Battalion.

Disaster Management Group, of West Bengal Police has been functioning under Police Order No. 16 of 2009 Police Order No. 24 of 2011, Police Order No. 1 of 2013 and Police Order No. 1 of 2025. Now this order is issued in suppression of all earlier orders and will come into force from the date of issuance of this order.

Formation of One State Disaster Response Force (SDRF) Battalion is under consideration by the Govt. of West Bengal. Pending formal Government Order, one ad-hoc SDRF Battalion will be raised from the available resource of West Bengal Police. All the Disaster Management Group of West Bengal Police will now function under the SDRF Battalion with immediate effect.

ROLE OF SDRF

- a) Provide specialized response to disasters, natural or man-made, for rescue and relief.
- b) Deployment in case of impending disasters.
- c) Assistance to civil authorities in distribution of relief materials.
- d) Co-ordination with other agencies engaged in rescue/relief work.
- e) Impart training to the Local Police / HG/ NVF/CV.
- f) To work in community capacity building for disaster response.
- g) Capacity building through familiarization exercise, community awareness programs, mock exercise, organizing workshop cum exhibition and individual training etc.

TASK OF SDRF

- a) Deployment in case of impending disaster.
- b) Provide specialized response for rescue and relief in case of disasters which cover:
 1. Chemical Emergencies.
 2. Extrication of victims during flood, Accident, Collapse of Building/ Infrastructure.
 3. First Medical Response to victims.
 4. Assistance to civil authorities in distribution of relief material.
- c) Coordination with other agencies.

STRENGTH AND COMPOSITION OF SDRF BATTALION

As a part of Capacity Building under Disaster Management Act-2005, Formation and authorized strength of SDRF Bn. is **1151** as per **Annexure-I**, comprising of various ranks of operational, and other administrative staff. SDRF Battalion is composed of 09

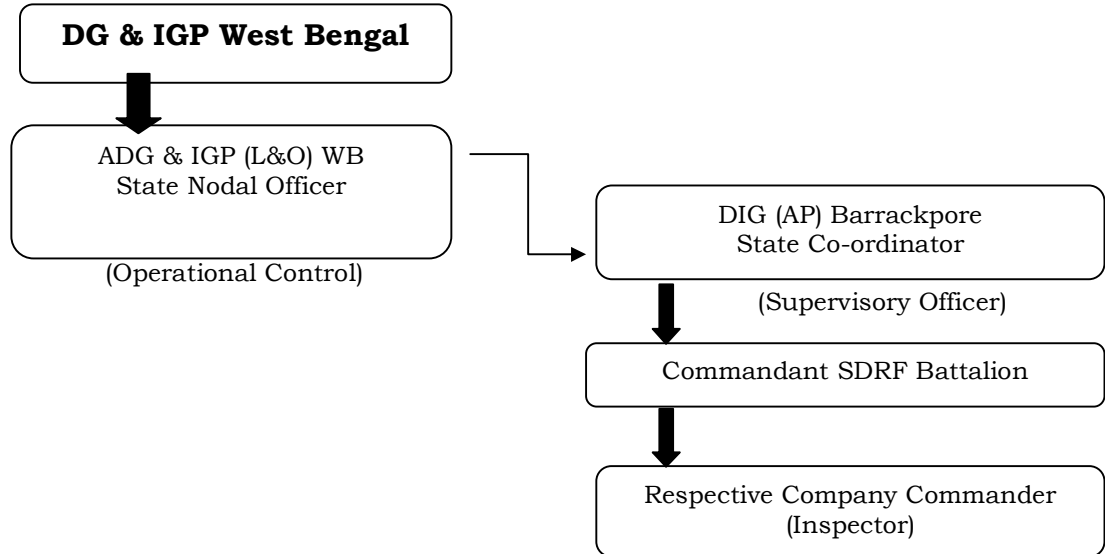
Coys (Coy A to Coy I) and one HQ Coy to be drafted from various Armed Police Battalion of West Bengal Police. **Thus all 72 specialized Search & Rescue Teams (08 Teams in each Coys)** which include specialized manpower & resources (CSSR/MFR/Surface & Deep Dive Water Rescue/ High Rise Building/ Mountaineering / Rock Climbing). Out of 72 SAR teams, 45 SAR teams will be placed into service for deployment at any given time whereas remaining SAR teams would be deployed within next 48 hours. Regarding CBRN, 5 teams (Barrackpore –2 teams, Salua –1 team, Barjora –1 team and Dabgram –1 team) shall be earmarked and trained to address as a first responder for any CBRN emergency.

LOCATION OF SDRF COYS :-

1. Head Quarter :- Barrackpore
2. South Bengal Zone :- Barrackpore – 02 Coys & Krishnagar- 01 Coy.
3. Western Zone :- Barjora 01 Coy., Durgapur 01 Coy. & Salua – 01 Coy.
4. North Bengal Zone :- Dabgram -02 Coys & Malda – 01 Coy.

Apart from AC (HQ) at BHQ, in each zone 01 (one) officer in the rank of Assistant Commandant will supervise the function of the SDRF Coys. located there.

ORGANIZATION STRUCTURE OF SDRF BN. :-



DIG (AP) Barrackpore being assisted by Commandant and Assistant Commandant (HQ), SDRF will be the Coordinating Officer for raising, equipping and training of SDRF Personnel. The overall State Nodal Officer of SDRF will be ADG & IGP (L & O), WB.

MANPOWER

Strength of manpower for SDRF of west Bengal Police will be drafted from Various Armed Police Battalions as per guidelines of Police Orders issued from time to time and on the basis of their physical endurance which will be judged by a committee under the chairmanship of DIG (AP) Barrackpore. Age profile of ranks for induction in SDRF - Constable maximum 30 years, ASI maximum 35 years, SI maximum 30 years and Inspector maximum 45 years.

TRAINING

Newly drafted Manpower will undergo 08 (eight) weeks basic training at SDRF Bn HQ and thereafter undergo 02 (two) weeks specialized course under NDRF/ NISA/ NEPA or other various specialized agencies as deem fit by the competent authority. After completion of Basic and advance training all will be inducted to SDRF Battalions for a period of 05 (five) years and extendable for another 02 (two) years subject to physical ability.

Apart from Basic Training, two weeks in-service training will be organized by BN HQ. All the personnel posted in all Coys should participate in the said training in phased manner. On the basis of the performance personnel will be selected for ToT / MoT organized by various specialized agencies. Besides, Commandant will also formulate and organize Three (03) weeks basic DM course for SIs/ASIs/ Constables/ HGs/ NVFs/ Civics of Districts & Commissionerates under West Bengal Police as per directive issued from competent authority.

ACCOMMODATION

Existing infrastructure of Armed Police Battalions of West Bengal Police will be utilized for newly raised SDRF Battalion. DIG (AP) Barrackpore and State Co-ordinator will issue necessary order in this regard.

EQUIPMENT

Existing equipment and gadgets presently possessed by various DM unit of WBP will be utilized by the newly raised SDRF Bn. For procurement of new equipment, AMC of existing equipment, repairing of equipment, Condemnation etc., A Committee will be formed by State Nodal officer and State Co-ordinator with other officers having knowledge in this regard.

MOBILITY

For mobility of SDRF Personnel, scale of vehicle has been given in annexure-I. Necessary order (hiring / procurement and POL) will be issued by the competent authority of WB Police directorate. Necessary order for POL and Lubricant for equipment will also be issued from WBPd.

Regarding Uniform, Symbol, Flag, conduct and other duties of various ranks of SDRF personnel will be issued by the competent authority.

DE-INDUCTION

On completion of any operation / Rescue, the Coy / Team commander will take decision on de-induction after received order from BHQ / PHQ control room. In case of major operations, the Commandant will take clearance from PHQ / State Nodal Officer before ordering de-induction.

SDRF personnel should not be retained in district / commissionerate for a longer period of time unless there is any exigency.

SDRF personnel, from AC downwards, are not to be deployed for routine Law & Order or other routine purpose without the express direction of DG & IGP, WB.

DG & IGP, West Bengal may at any point of time revise, relax or repeal any of clauses of the Police Order as and when required.
