I have been receiving threats from several ends of finishing my and our family's lives. That my life is in grave danger as they targeted me as I along with my family members have been physically and mentally manhandled. As I was supporting BJP and I was appointed as polling agent of BJP. Even I am not secured at my respective houses. That at present I am not secure at all and am feeling very much insecure regarding my and my family's security. I did not lodge any complain agaisnt them as I was panick and terror in their fear. They again threatened me in the same manner and style. I was victim of Post poll voilence of 2021. Hurling of Bombs at my residence was happened at my residence. If any unforeseen events occured with me , they shall be responsible.

Such behavior is unacceptable and goes against my rights. I feel extremely threatened and intimidated by the actions of the TMC leader and request your immediate intervention in this matter. I seek your assistance in ensuring our safety.

I urge you to investigate this incident thoroughly and take appropriate action against the individuals responsible for such coercion. I trust that you will uphold justice and provide me with the necessary support in this challenging situation.
