NOTICE INVITING TENDERS FOR REMODELING OF CANVAS BAGS

The West Bengal Police Recruitment Board has approx 500(Five hundred) water resistant cotton canvas bags with 'duck' weave of olive green colour. Specification of the bags as follows:-

These bags have square bottom measuring 38 cm (15 inches) x 38 cm (15 inches) with a height of 82 cm (34 inches) and having a canvas density of 410 gsm (i.e., 12 ounces per sq. yard) and a carrying capacity of 25 kgs per bag. The bags with a strong top rope at the mouth running inside a stitched channel of 3.5 cm width with the midpoint of the rope length is stitched to the channel at the far end so that it remain within the channel when the two ends of the rope are drawn together from the slit end. The bags have 7 stainless steel (S.S) rings of 3.25 cm diameter and of 12 SWG (2.64 mm) wire thickness stitched into 7 strong loops of 14 cm length and 3.5 cm width which is stitched 7 cm below the mouth of bag with the loops holding the S.S rings. The first pair of loops is stitched 3 cm away from the vertical seam and one loop is stitched on the side opposite to the vertical seam. The next two pairs of loops are stitched at equal distances approximately 25 cm apart. Each of the loops contains an S.S ring on the top. The middle of the second rope is stitched to the 4th loop. A transparent plastic packet of 12 cm x 24 cm dimension is stitched on the outside (both sides) with a lining and opening on one side closed with a Velcro strip for inserting Address cards into the pouch for identifying the addressee of each bag, at a height of 30 cm from the base. The letters 'NO HOOK' is printed at 4 cm height, with the stroke width being 8 mm and the gap between the letters 5 mm is stenciled in white fabric paint and placed 2 cm below the transparent jacket on both the sides of the bag. The icon for "No Hook" of 12 cm in diameter is placed below the words "No Hook". The words 'WBPRB' is also similarly stenciled on both sides of the bags 4 cm above the bottom stitches of the bag of 4 cm height, 8 mm stroke width and 5 mm gap between the letters.

Now the Board intends to reform these cotton canvas bags with specific criteria as specified below:-

These bags should have a square bottom of 14.75"X14.75" with a height of 32.75" made of canvas density of 410 gsm and a carrying capacity of 30 kgs per bag. These bags must be stitched, folded and stitched (double stitched) at the seams from the inside and the bottom side must be have two stitches running close to each other for added strength. The bags must be made tamper-proof and pilfer-free so that it does not result in loss of confidential material during transit. The bags should also have 12 stainless steel (S.S) rings of 3.25 cm diameter and of 12 SWG (2.64 mm) wire thickness stitched into 12 strong loops of 4" length and 1.5" width

which in turn would be stitched below the mouth of bag with the loops holding the S.S rings. A transparent plastic packet of 12 cm x 24 cm dimension stitched on the outside (both sides) with a lining and opening on one side closed with a Velcro strip for inserting Address cards into the pouch for identifying the addressee of each bag, at a height of 30 cm from the base. The letters 'NO HOOK' must be of 4 cm height, with the stroke width being 8 mm and the gap between the letters 5 mm stenciled in white fabric paint and placed 2 cm below the transparent jacket on both the sides of the bag. The icon for "No Hook" must be 12 cm in diameter placed below the words "No Hook". The words 'WBPRB' must also be similarly stenciled on both sides of the bags 4 cm above the bottom stitches of the bag of 4 cm height, 8 mm stroke width and 5 mm gap between the letters. A serial number on each bag must also be stenciled starting from 2 cm above the Address Card jacket.

Sealed tenders are invited from bonafide manufacturers, fabricators and suppliers to reform the bags mentioned above.

Certification: All bidders must produce self attested copies of PAN card, GST Certificate, Income Tax Certificate for the last assessment year.

EMD: The intending participants shall have to deposit an earnest money amounting of Rs. 1,000/- (Rupees one thousand only) in form of Demand Draft in favour of West Bengal Police Recruitment Board, payable at Salt Lake/ Kolkata from any Nationalized Bank. The failure/ omission to deposit EMD shall disqualify the tender bid. No interest shall be payable in respect of EMD.

In case a successful bidder backs out/ or fails to take up the job under the contract the amount of EMD shall be forfeited by the authority.

Earnest money of unsuccessful bidders will be released after award of work to the successful bidder.

Rates: Rates will be exclusive of all taxes as applicable.

The tender evaluation committee reserves the right to accept or reject any or all of the bids without assigning any reason whatsoever at any time prior to award of the contract indemnifying itself from any liability and would be under no obligation to inform the bidders of the grounds of such a decision.

The sealed tenders must be superscribed with the words "**Tender for remodeling of Cotton canvas bags**" address to Superintendent of Police & Member, West Bengal Police Recruitment Board Araksha Bhaban (5th floor), Block - DJ, Sector - II, Salt Lake City, Kolkata - 700 091 and dropped in the tender box kept for that purpose within 09/02/2022 (upto 3:00 PM & will be opened at 4:00 PM on 09/02/2022). Interested bidders may visit the office of WBPRB on any day between Monday and Friday (Except Government Holiday) during office hours to inspect the specimen of the bag.
