The applying agency / firm must be registered with PAN, GST & P. Tax of current validity.

#### **Terms & Condition:-**

- i. Bills with challans along with Work done / Satisfactory Certificate from the concerned authority must be submitted to the office of the undersigned for payment.
- ii. The final amount reflects in the financial did by the bidder (S) will be treated as inclusive of all taxes. GST, Delivery cost, all direct & Indirect Taxes, All Incidental in the said financial did.
