2. Both Technical bid and Financial Bid are to be submitted concurrently duly signed digitally in the website : <https://wbtenders.gov.in>
3. The Technical Bid and Financial Bid are to be submitted online as per terms (schedule attached)
4. The Tender Committee will consider only if the tender qualities in the Technical Bid. The decision of the Commissioner of Police, HPC will be final. The list of qualified tenders will be displayed in the website on the scheduled date and time.
5. Where there is a discrepancy between the unit rate & the line item total resulting from multiplying the unit rate by the quantity, the unit rate quoted shall govern. Any time, the schedule, specification may be changed; agencies are bound to do any change of work without any query.
6. Running payment for work may not be made to the executing agency.
7. Tender shall remain valid for a period of 180 (One hundred eighty) days after the final date of submission of Financial Bid.

PLACE OF BID OPENING ONLINE:

9. Since B.O.Q. for the work under this N.I.T is based upon the schedule of rates of Public Works Dept. for Building , Sanitary, Plumbing works & Electrical works with up-to-date Addenda & Corrigendum, the renderers shall quote their rate accordingly considering that no escalation and or price adjustment will be allowed thereto under any circumstances.
10. No Mobilization Advance and Secured Advance will be allowed.
11. The accepting authority reserves the right to reject any or all the tenders without assigning any reason whatsoever and he will not be bound to accept either the lowest tender or any of the tenders.
12. Issuance of work order as well as payment will depend on availability of fund and no claim whatsoever will be entertained for delay of Issuance of work order as well as payment, if any, intending tenders may consider these criteria while quoting their rates.
13. As per GO No 796-F(Y), Dt. 25.02.2022 from Govt. of W.B. Finance Dept.(Audit Branch), the eligible bidder have to submit additional performance security @ 10% of tendered amount besides the Security Deposit @ 10% of tendered amount if the accepted bid value is 80% or less of the amount put to tender. The additional all performance security shall be submitted in the form of bank guarantee from any nationalized bank within 7 working days from the date of issuance of letter of acceptances, if failed his EMD will be forfeited and other necessary actions like blacklisting of the contractor, etc. may be taken. The bank guarantee will be returned after successful completion of the work. If the bidder fails to complete the work successfully the bank guarantee will be forfeited at any time during the pendency of the contract period after serving proper notice to the contractor.
14. If any three (3) letters issued to any agency for his/her bad workmanship and negligence of work, he/she also be black listed from this Department up to three (03) years.
15. Any bidder should submit the original documents for verification in this office when intimated.
16. Deduction of Tax shall be as below and as per provision of notification No. 5050 F(Y) dt. 16/08/2017 and as per latest Govt. order.
 - (i) GST is applicable as per Govt. order.
 - (ii) I.T will be deducted as per rule under section 194 of I.T Act.
 - (iii) Cess @ 1% (One Percent) of the cost of construction works will be deducted from the bills of the contractor or Labour Welfare Dept.
17. Successful Tenderers will be required to obtain valid Registration Certificate & Labour License from respective Regional Labour Offices where construction work by them are proposed to be carried on as per Clauses u/s 7 of West Bengal Building & other Construction Works' Act, 1996 and u/s 12 of Contract Labour Act.

18. Power of Attorney holders are not allowed to sign Tender Documents unless otherwise approved by Government.
19. Successful tenderers will be required to observe the following conditions strictly :-
 - a) Employees' Provident Fund and Miscellaneous Provisions Act, 1952 and Employees State Insurance Act 1948 should be strictly adhered to wherever such Acts become applicable.
 - b) Minimum wages to the workers shall be paid according to the rates notified and/or revised by the State Government from time to time under the Minimum Wages Act, 1948 in respect of scheduled employments, within the specified time as per law. Payment of bonus, wherever applicable, has to be made.
 - c) Adequate safety and welfare measures must be provided as per the provisions of the Building and other Construction Workers' (Regulation of Employment & Conditions of Service) Act, 1996 read with West Bengal Building and other Construction Workers (Regulation of Employment and Conditions of Service).
 - d) All liabilities arising out of engagement of workers are to be duly met before submission of bills for payment.
20. If there is any violation of any or all the relevant above criteria during execution of the job, it will render the concerned agencies ineligible for the work then and there or at any subsequent stage as may be found convenient.

21. Draft proforma for Non – Conviction (in a form of affidavit in Rs. 10 Non – Judicial Stamp Paper)

The bidder shall provide an undertaking that the proprietor / promoter /director of the firm, its employee, partner or representative are not convicted by a court of law for offence involving moral turpitude in relation to business dealings such as bribery, corruption, fraud, substitution of bids, interpolation, misrepresentation, evasion or habitual default in payment of taxes etc. The firm does not employ a Government servant, who has been dismissed or removed on account of corruption. The firm has not been debarred , blacklisted by any govt . ministry / department / local govt./ PSU etc. In the last two years from scheduled date of opening of this E-Tender.

INSTRUCTION TO BIDDERS

SECTION – A

General guidance for e- Tendering

Instructions/ guidelines for electronic submission of the tenders online have been annexed for assisting the contractors to participate in e- Tendering.

1. Registration of Contractor :

Any contractor willing to take part in the process of e- Tendering will have to be enrolled & registered with the Government e-Procurement system.

A. Technical Proposal : BID

The Technical proposal should contain scanned copies of the following in two covers (folders).

A-1. Statutory Cover files Containing:

- i) Earnest money (EMD) as System Generated.
- ii) Documents for NIT (Properly upload the same Digitally Signed).
- iii) Upto date Professional Tax (P.T) deposit receipt challan, Pan Card, Upto date I. T. receipt, GST Registration Certificate.
- iv) Registration Certificate under Company Act. (if any).
- v) Registered Deed of partnership Firm/Article of Association & Memorandum.
- vi) Power of Attorney (For Partnership Firm/Private Limited Company, if any)
- vii) Registration Certificate issued by the Assistant Registrar of Co-Op(S) (ARCS) bye laws are to be submitted by the Registered Labour Co-Op.(s)/Engineers' Co.-Op.(s)
- viii) Do not upload unnecessary and old documents which is not related to this notice, Checking should be done chronologically, if any mistake/misplace, authority do not responsible, therefore only valid documents are to be uploaded.
- ix) The prospective tenderers shall have satisfactorily completed as a prime agency during the last 5(five) years prior to the date of issue of this Notice at least 1(one) work of similar nature under the authority of State/ Central Govt. etc and having a magnitude of 40(forty) % of the estimated amount put to tender or 2(two) similar nature of completed work, each of the minimum value 30% of the estimated amount put to tender.

Note: - Failure of submission of any of the above mentioned documents of the tender is liable to be rejected for both statutory & non statutory cover.




